The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, January 28th, 2014, with Bob Beck, Jim Cary and Tom Broeker present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: the County Auditor announced that she has made arrangements for a speaker from Iowa State University to conduct township officers training on Wednesday, January 29th. Other department heads will also be present to inform the clerks and trustees about their office's duties. That meeting will be held at Starr's Cave Nature Center. CPC Ken Hyndman reported that he will be attending a meeting with mental health providers at Henry County on Friday, January 31st. Broeker discussed a bill for an autopsy performed on a man who died in Burlington. This county forwarded the bill to Scott County. That county returned the bill because the obituary mistakenly said the man resided in Burlington. However, several sources verified that this person was in fact a resident of Scott County. Sr. Assistant County Attorney Amy Beavers said Des Moines County could file a small claims case against Scott County. The Board directed her to file the claim. County Attorney Pat Jackson reported that one office in his new location does not have heat and the bank will install baseboard heaters.

Land Use Administrator Jeff Hanan presented the Resolution and Final Plat for Tucker Farms, LLC Subdivision. Hanan stated the purpose of the division was to separate the agricultural buildings from tillable land. Motion to approve was made by Cary and seconded by Broeker.

Broeker moved to approve minutes for the Board meeting held on January 21st, 2014. Seconded by Cary. The results for an election held on January 8th, 2014, for Trustee of Burlington North Bottoms Levee and Drainage District were canvassed. Five votes were cast for Andrew Hoth for a 3 year term. Broeker moved to approve the results as canvassed. Seconded by Cary.

During other business, a Resolution approved by ISAC in support of phasing in a ten cent fuel tax increase was given to the media.

During committee reports, Cary had attended a RUSS meeting and reported that DNR isn't giving a \$50,000 grant to this group. RUSS was instructed to pass the shortfall to the member counties. RUSS is waiting for an attorney's opinion. If Des Moines County has to help cover the loss, the county will pay \$13,860 next year. Cary has talked to area state representatives for help with the DNR decision. Broeker attended a meeting with health care providers and judges regarding problems at the jail when mental health patients are not properly placed. Beck stated that he had received a request from Robert and Janet Hesler for a letter of support from the county for the Danville Museum. He asked the Auditor to write this letter.

Meeting was adjourned at 9:42 AM.

A work session to discuss the County budget was held. Budget Director Cheryl McVey presented three scenarios for the General Basic levy. The Board agreed to fund Steamboat Senior Center, Battered Women's Shelter, Tourism and the law library for F/Y 15. Two other requests from non-mandated agencies were denied.
