November 18, 2014

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9:00 AM on Tuesday, November 18, 2014 with Bob Beck, Jim Cary and Tom Broeker present.

Unless otherwise noted, all motions carried.

Judge Brown gave the Oath of Office to County Attorney Amy Beavers and County Recorder Lisa Schreiner. Since both were appointed to their positions prior to the election they were given the oath within 10 days after the 2014 General Election canvass.

Meet with Department Heads: Terri Johnson, Deputy Auditor reported on two upcoming special elections for December 2, City of Burlington and West Burlington School District. Ballots should arrive today or tomorrow. County Engineer Brian Carter reported his crews were out blading snow Saturday evening. Construction projects have temporarily been halted. Construction may start up again if the weather warms up. County Recorder Lisa Schreiner reported ATV and Snowmobile renewals are due by the end of December. County Attorney Amy Beavers reported their office has gone live with the new EDMS (court paperless system). Safety Director Angie Vaughn reported her office is conducting CPR classes for employees. So far about fifty employees have trained during five classes.

Accounts Payable Claims in the amount of \$447,757.28 were approved upon motion by Broeker and second by Cary.

The County Treasurer's Office sent a request to suspend real estate taxes for a property in Burlington. Broeker stated this is a suspension of taxes not abatement of taxes. The suspension was approved upon motion by Broeker and second by Cary.

The following personnel actions for the County Attorney's Office were received: Todd E. Chelf, Assistant County Attorney promotion. New rate is \$52,000, effective 11/17/2014. Justin C. Stonerook, Assistant County Attorney promotion. New rate is \$60,000, effective 11/17/2014. Cary motioned to approve the actions and seconded by Broeker. A personnel action in the Recorder's Office was received: Margo C. Edwards, Deputy is retiring effective 12/31/2014. Broeker motioned to approve the action and seconded by Cary. A personnel action at the Correctional Center was received: Shafer McCune, PT CO resigned effective 10/1/2014. Cary motioned to approve the action and seconded by Broeker.

The following reports were received and filed in the Auditor's Office: Clerk's Report of Fees Collected, October 2014 Sheriff's Monthly Report, October 2014

Broeker motioned to approve minutes for the regular Board meeting held on November 10, 2014. Seconded by Cary.

Beck, Cary and Broeker attended the ISAC Fall School in Des Moines last week. They discussed the unfunded mandates forced upon counties at the meetings. They thanked Ken Hyndman, Community Services Director for the Crisis Center Services presentation at ISAC. Broeker attended a Greater Burlington Partnership meeting.

Meeting was adjourned at 9:27 AM.

A work session was held to discuss the Subdivision Ordinance and process. In attendance were the Board of Supervisors Bob Beck, Jim Cary and Tom Broeker, Land Use Administrator Jeff Hanan, County Attorney Amy

Beavers, County Engineer Brian Carter, County Recorder Lisa Schreiner, Des Moines County Zoning Commission members Larry Werner, Richard Keith, Ron Breuer, John Roth, Ron Wunderlich and County resident Dale Oaks. Jeff Hanan went over the steps of the subdivision process: He checks with Auditor's Office to verify if split will require a subdivision plat. Requires the subdivision plat to meet the requirements for plat and review process. A copy of the plat is sent to several departments for review with a deadline. If a review is not returned by a department, Jeff assumes the plat to be OK. The Health, Roads and Fire Department are the most critical reviews. Fencing requirements currently follow the DOT standard fence. Fencing waivers are available. The Subdivider is responsible for obtaining the adjoining owners signatures on the waiver. Dale Oaks discussed the fencing requirements. There was discussion regarding what are the standards for a fence. Mr. Oaks stated the intent for fencing is to protect the farmer from residential development and keep livestock confined. Adjoining landowners use the right hand rule for maintaining their portion of the fence. Residential lots create a larger problem for the rule. More discussion was held regarding CSR ratings and agricultural land determinations. The Zoning Commission stated they will be reviewing the subdivision ordinance and suggesting changes.
