May 26, 2015

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, May 26th, 2015, with Jim Cary and Tom Broeker present. Bob Beck was absent.

Unless otherwise noted, all motions carried.

Meet with Department Heads: DCS Ken Hyndman reported that Directors of Community Services across the region are continuing to work with providers to get contracts for next fiscal year. Doug Ervine, Jail Administrator, reported that there will be a jail inspection on June 2nd.

County Attorney Amy Beavers administered the oath of office to Assistant County Attorney Christopher Scarborough.

Burlington Police Chief Doug Beaird presented the grant application for the Edward Byrne grant in the amount of \$19,400. He stated that the City will be using \$11,453 to increase their electronic storage for body camera imaging. The County Sheriff will receive \$7,004 for additional electronic storage. The Sheriff's office will also receive a body camera costing \$855. Broeker moved to approve. Seconded by Cary.

County Engineer Brian Carter presented a Memorandum of Understanding with the City of Burlington to improve Mill Dam Road. The City will pay for 50% of Division One and the County will pay the remainder. Carter stated that the project will be let by the beginning of July and will take three to four weeks to complete. Motion to approve was made by Broeker and seconded by Cary.

County Treasurer Janelle Nalley-Londquist presented a request to assign Tax Sale Certificate #11-0447 to an adjacent property owner. Martha Swailes, 720 S. 4th St., has offered to pay a total of \$637 on the taxes. The remainder will be abated after the deed is issued to Swailes. Nalley-Londquist recommended approval. Motion to assign the tax sale certificate was made by Broeker and seconded by Cary.

The County Auditor reported that Henry M. Adkins & Son, Inc. of Clinton, MO submitted the low quote for new election machine equipment and she recommended that their quote be accepted. Broeker stated that the quote was less than the amount budgeted and moved to approve. Seconded by Cary. The machines will be paid for over a three year period with no interest.

The County Auditor presented a contract with Howard E. Nyhart Company, Inc. to perform the biennual GASB 45 financial report and recommended that it be approved. Motion to approve was made by Broeker and seconded by Cary. Nyhart will be paid \$3,500 for this service.

The County Auditor presented an amended Electronic Transactions Clearinghouse 28E Agreement. This is for secure transmission of confidential information from the Community Services offices to the State and the membership is paid by Hyndman's department. Motion to approve was made by Broeker and seconded by Cary.

Broeker moved to approve a Right of Way Easement for Lisco (Local Internet Service Company) across county property west of Racine Ave. and under Walton Lake. Lisco will be running fiber optic cable through the easement. Seconded by Cary.

Broeker moved to approve the hiring of Hillary M. May as part time C O at the Correctional Center. Seconded by Cary. May's employment begins May 26th and she will be paid \$10.55 per hour.

Broeker moved to approve minutes for the Board meeting held on May 19th, 2015. Seconded by Cary.

During committee reports, Broeker attended the annual two day meeting of Mental Health Disability Services Governing Board. Cary had met with Bruce Hudson with RUSS regarding the lawsuit against Mt. Union. Meeting was adjourned at 9:32 AM.
