The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, July 21st, 2015, with Jim Cary, Tom Broeker and Bob Beck present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: Conservation Director Chris Lee reported that the retest of Big Hollow Lake showed the water was fine. He thinks the previous test results were an error. Doug Ervine, Jail Administrator, reported that the facility is at capacity and he is considering moving some prisoners to another county.

The following correspondence was received: a letter from the Iowa Dept. of Veterans Affairs regarding the annual grant application for the local Veterans Affairs office.

Accounts Payable Claims in the amount of \$728,592.83 were approved for payment upon motion by Broeker and second by Beck.

Broeker moved to approve the First Amendment to an Agreement for Inmate Health Care Services. Ervine stated that this will be the seventh year the jail has used this company. The contract shows an increase of 2.43%. There is a 3% savings if the contract is paid in full so it is included in the Accounts Payable Claims today. Motion was seconded by Beck.

A liquor license for the Buras wedding at the Barn on the Ridge was approved upon motion by Beck and second by Broeker.

The following reports were received and filed: Clerk's Report of Fees Collected, June 2015 Auditor's Report of Fees Collected, Qtr ending June 2015 Treasurer's Office, Semi-Annual Report for Byar Trust, Qtr ending June 2015 Report of Services Provided by Veterans Affairs, Qtr ending June 2015

Minutes for the regular Board meeting held on July 14th, 2015 were approved upon motion by Broeker. Beck seconded.

During other business, Broeker reported that pursuant to a work session several weeks ago, he had contacted US Bank about leasing additional space for the County Attorney. He hopes to have a proposal from them next week.

During committee reports, Broeker had attended a Case Management meeting, where he learned that there are now over 1,000 people on the ID waiting list. He also attended a MHDS meeting and reported that the schedule to implement the bed tracking system has been moved back to August 1st. Beck had attended the Community Health Needs Assessment meeting. The group decided that major concerns in this county are obesity, access to mental health care and meeting recreational needs of the area. Iowa currently ranks 48th in access to health care.

Meeting was adjourned at 9:17 AM.

A work session was held regarding the responsibilities of the Patient Advocate. As of July 1st, the Patient Advocate, Sallie Benedict, works under the direction of the County Supervisors instead of the Chief Judge of District Court. Benedict asked that the County Auditor be her contact for approval of cases and reimbursements instead of the Director of Community Services in order to align with procedures in other MH regions. Rules for this position are being rewritten and that group will be meeting on August 17th. The Supervisors withheld comment until they can read the new rules.
