September 15, 2015

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, September 15, 2015, with Jim Cary, Tom Broeker, and Bob Beck present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: Maintenance Supervisor Rodney Bliesener reported that he is listing lost bikes and a vehicle owned by Public Health on govdeals.com. Barb Baker, Director of Public Health, reported that her department will be involved in the Life Style 60+ Expo at Westland Mall on Wednesday. On September 26th, her department, along with the Narcotics Task Force, Burlington PD and HazChem, will collect expired prescription medications at HyVee on Agency. Sharps containers will be exchanged for empty containers. Mercury thermometers will be traded for digital ones. DCS Ken Hyndman attended a meeting of the SEIL regional board. Member counties are concerned about the State's agreement to have Medicaid administered by four private companies. Case Management is currently being handled by the counties but there is a six month gap in coverage when Case Management might need contracts with the companies in order to serve their clients. County Attorney Amy Beavers attended ME training in Ankeny last week. Her office plans to participate in the City's Safe Trick or Treat program this year. County Recorder Lisa Schreiner reported that all of the microfilmed military discharge records have been digitized. She will be attending an Iowa Land Records seminar for e-submissions on Wednesday. Schreiner will be closing her office on October 14th from 10 AM to 1 PM for her staff to be trained by Iowa Department of Public Health.

Accounts Payable Claims in the amount of \$407,841.13 were approved upon motion by Beck and second by Broeker.

Dan Eberhardt with Regional Planning presented a Resolution for the County to financially support the Great River Housing Trust Fund for F/Y 2017. Eberhardt stated that the agreement will provide part of the 25% local match for low to moderate income housing or improving existing structures in Des Moines County. Last year, the region received \$230,000 for this program from the Iowa Finance Authority. This year, the application is for \$285,000 and the total local match is \$71,000. Des Moines County will contribute \$10,000. Motion to approve the Resolution was made by Beck and seconded by Broeker.

RESOLUTION

A RESOLUTION AUTHORIZING DES MOINES COUNTY TO FINANCIALLY SUPPORT THE GREAT RIVER HOUSING TRUST FUND FOR FISCAL YEAR 2017

WHEREAS, that said DES MOINES COUNTY is a duly recognized governing body acting under the laws of the State of Iowa; and,

WHEREAS, that said DES MOINES COUNTY in assisting this regional development activity will sustain a viable housing program for the entire region and,

WHEREAS, DES MOINES COUNTY is a member of the Great River Housing Trust Fund, a regional housing non profit corporation that assists low and moderate income households in the region,

WHEREAS, DES MOINES COUNTY residents and businesses have benefitted economically through sustained taxes and supply purchasing through the Great River Housing Trust Fund's Programs,

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE DES MOINES COUNTY BOARD OF SUPERVISORS THAT:

DES MOINES COUNTY will contribute \$10,000 cash match to the Great River Housing Trust Fund thus benefiting low to moderate income households in the county and the region.

Brian Carter presented the contract for bridge repair on Flint Bottom Road. Cole Construction, Inc. of Keosauqua bid \$77,473.00 and will repair the bridge abutment and remove flood debris. Carter stated that bridge repair will be completed by December and debris removal will be done by February. He recommended approval. Broeker moved to approve. Seconded by Beck.

David Toyer with Greater Burlington Partnership presented a Resolution authorizing funds to be allocated in support of a County-wide housing needs assessment. Toyer stated that Burlington and West Burlington have pledged financial support and he is seeking \$1,000 from the County. Motion to approve was made by Broeker and seconded by Beck.

RESOLUTION A RESOLUTION OF DES MOINES COUNTY IOWA AUTHORIZING FUNDS TO BE ALLOCATED IN SUPPORT OF A COUNTY-WIDE HOUSING NEEDS ASSESSMENT

WHEREAS, the Des Moines County is a duly recognized government subdivision acting under the laws of the State of Iowa; and

WHEREAS, the Board of Supervisors is the duly elected governing body of Des Moines County; and

WHEREAS, under Chapter 48 of the Iowa Administrative Code, housing needs assessments are a necessary precondition for developments which seek to construct new or rehabilitate dilapidated housing units and qualify for the Iowa Workforce Housing Tax Credit Program; and

WHEREAS, the Greater Burlington area has experienced a tight housing market for several years and there is a lack of market information to identify the area's housing needs particularly as it pertains to workforce housing; and

WHEREAS, there is a desire for Des Moines County and its cities to complete a housing needs assessment in order to determine if future housing development in the area will be able to qualify under the Iowa Workforce Housing Tax Credit Program for state tax incentives; and

WHEREAS, the Des Moines County has been asked to contribute \$1,000 and join other public and private sources of funds in order to cover the cost of a housing needs assessment with an estimated total project cost of \$25,000; and

WHEREAS, the Board of Supervisors supports fully the need to complete a housing needs assessment to obtain information on the area's workforce housing needs, as housing is a critical component of both economic development and growth of the area's workforce.

NOW, THEREFORE, BE IT RESOLVED, That the Board of Supervisors in Des Moines County, Iowa hereby allocates \$1,000 from economic development toward the cost of a housing needs assessment, which project is to be managed by the Southeast Iowa Regional Planning Commission.

BE IT FURTHER RESOLVED, the Board of Supervisors authorizes the Chair of the Board to sign any necessary agreements in order to carry out this authorization.

A work session was held to discuss plans to complete Phases 2 and 3 of the Flint River Trail. Zack James with Regional Planning went through the plans with the Supervisors. The trail project includes: a parking lot at south trailhead off of N Prairie Grove Rd, resurface existing 155th St to limestone surface and a parking lot at SE Corner of Big Hollow off of 180th St. Brian Carter, County Engineer, and Chris Lee, Director of Conservation, were also present.
