The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, June 28<sup>th</sup>, 2016, with Bob Beck and Jim Cary present. Tom Broeker was absent.

Unless otherwise noted, all motions carried.

Meet with Department Heads: the County Auditor announced that persons wishing to vote early for the West Burlington City Council Special Election can vote until 11 AM on July 5<sup>th</sup>. Her office will be open until 5 PM on Friday, July 1st, the last day that an absentee ballot can be mailed. Jail Administrator Doug Ervine reported that the State Inspector checked the jail on Friday. Some maintenance issues were noted but they were already scheduled to be done next fiscal year.

Under correspondence, Gary Stephenson of Fort Dodge, Iowa, sent a letter asking for donations to continue placing prints of the Constitution in Iowa Courthouses.

Cary moved to approve Accounts Payable claims in the amount of \$1,164,222.19. Seconded by Beck.

A Resolution approving issuance of General Obligation Loan Agreement Anticipation Project Note in the amount of \$1,250,000 was approved upon motion by Cary. Seconded by Beck.

## RESOLUTION

Authorizing the issuance of a General Obligation Loan Agreement Anticipation Project Note in a principal amount not to exceed \$1,250,000

WHEREAS, the Board of Supervisors of Des Moines County, State of Iowa, has heretofore proposed to enter into a General Obligation Loan Agreement (the "Loan Agreement") in a principal amount not to exceed \$3,000,000, pursuant to the provisions of Section 331.402 of the Code of Iowa, for the purpose of financing certain County insurance programs; repairs, improvements and equipment for County buildings and acquiring vehicles for the County Sheriff and health department (the "Projects"), and the County has published notice of such proposal and held a hearing thereon; and

WHEREAS, it is necessary to authorize the issuance of a General Obligation Loan Agreement Anticipation Project Note (the "Project Note") in an amount not to exceed \$1,250,000;

NOW, THEREFORE, Be It Resolved by the Board of Supervisors of Des Moines County, Iowa, as follows:

Section 1. The Project Note is hereby authorized to be issued to Danville State Savings Bank (the "Purchaser"), in anticipation of the receipt of and being payable from sources to be received and expended in connection with the Projects. The Project Note shall be signed by the Chairperson and attested by the County Auditor and delivered to the Purchaser, shall mature on June 30, 2017, and shall bear interest at the rate of 1.50% per annum payable as set out in the Project Note, except as the provisions hereinafter set forth with respect to redemption prior to maturity may be or become applicable hereto.

Section 2. Advances on the Project Note may be requested by the County Auditor in such amounts and at such times as are needed to pay the cost of the Projects, and the date and amount of each advance shall be entered by the Purchaser on the Schedule of Advances and Payments on the Project Note, and each advance shall bear interest from the date of such entry.

The County Auditor is hereby designated as the Registrar and Paying Agent for the Project Note and may be hereinafter referred to as the "Registrar" or the "Paying Agent."

The County reserves the right to prepay principal of the Project Note in whole or in part on any date prior to maturity upon terms of par and accrued interest. The date and amount of each such payment shall be entered by the Purchaser on the Schedule of Advances and Payments on the Project Note. All principal so prepaid shall cease to bear interest on the redemption date.

The Project Note shall be fully registered as to both principal and interest in the name of the owner in the records of the County kept for such purpose, after which no transfer shall be valid unless made on said records by the County Auditor, and then only upon a written instrument of transfer satisfactory to the County Auditor, duly executed by the registered owner or the duly authorized attorney for such registered owner.

- Section 3. The Project Note shall be in substantially the following form: see original document.
- Section 4. The revenues anticipated to be received by the County with respect to the Loan Agreement are hereby appropriated to the payment of the Project Note.

Section 5. It is the intention of the County that interest on the Project Note be and remain excluded from gross income for federal income tax purposes pursuant to the appropriate provisions of the Internal Revenue Code of 1986, as amended, and the Treasury Regulations in effect with respect thereto (all of the foregoing herein referred to as the "Internal Revenue Code"). In furtherance thereof, the County covenants to comply with the provisions of the Internal Revenue Code as they may from time to time be in effect or amended and further covenants to comply with the applicable future laws, regulations, published rulings and court decisions as may be necessary to insure that the interest on the Project Note will remain excluded from gross income for federal income tax purposes. Any and all of the officers of the County are hereby authorized and directed to take any and all actions as may be necessary to comply with the covenants herein contained.

The County hereby designates the Project Note as a "Qualified Tax Exempt Obligation" as that term is used in Section 265(b)(3)(B) of the Internal Revenue Code.

Section 6. All resolutions or parts thereof in conflict herewith are hereby repealed to the extent of such conflict.
