January 10th, 2017

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, January 10th, 2017, with Bob Beck, Jim Cary and Tom Broeker present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads:

County Engineer Brian Carter stated his crews were hauling riprap along Tama Rd. Sullivan Slough Road is closed due to an ice jam and the rising river level. He received a road petition, via email, from residents along Ferres Lane. This is an old subject regarding the residents wanting the road paved. Over the years he has attended several meetings with the land owners requesting the road to be paved. The Board will receive the petition next week as correspondence. Emergency Management Director Gina Hardin stated with the current weather warm up, hopefully this will break up the ice jam on the Mississippi River. She assumes the ice jam is in the vicinity where the Skunk River meets the Mississippi River. IT Director Gina Erickson stated her department is finishing a project with Secondary Roads, Conservation and Courthouse. They are combining telephone and internet services from four vendors to one and saving approximately \$13,737 a year. The internet speed will also increase for each location. Another project is moving the Patrol cars from Shield Mobile to a state program MOC. This will save about \$11,000 a year for support. A kickoff meeting for Tyler X financials was held in December and a second meeting was held January 9th. They plan to go live with the new system in December 2017. Conservation Director Chris Lee stated his department is moving forward on projects at Big Hollow. Chief Deputy Jeff White reported an incident Sunday night on Hwy 99. This could have been a potential dangerous dog at large issue. Some cattle were chased and broke thru their fencing and crossed the highway. One was attacked and received several bites. County Attorney Amy Beavers congratulated her First Assistant Ty Rogers on his recent appointment to District Associate Judge. Safety Director Angie Vaughan is continuing CPR training. Jail Administrator Doug Ervine is busy at the Jail. On Sunday they had 80 occupants with only 68 beds available. The transport officers have been busy. The sheriff's deputies have been assisting with the transports. Supervisor Beck asked the IT Director about the video court system. She stated her department has replaced parts but the same parts went bad. The system has paid for itself but needs to be replaced; it was installed for \$36,000 ten years ago.

Correspondence was received from Upper Mississippi, Illinois and Missouri Rivers Association (UMIMRA). They will host an annual meeting on February 9th and 10th at Pzazz in Burlington to discuss important steps to continuing to fight to reduce chronic flood risks in our region.

The Board approved the Compensation Board's Recommendations for elected officials for 2017. The salaries were reviewed last week and approved. Broeker motioned to approve the salaries as recommended. Cary seconded.
