## January 31<sup>st</sup>, 2017

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, January 31<sup>st</sup>, 2017, with Bob Beck, Jim Cary and Tom Broeker present.

Unless otherwise noted, all motions passed unanimously.

Changes to the tentative agenda – remove item 6(D)

Meet with Department Heads: Public Health Administrator Christa Poggemiller commented they were having phone issues but should be fixed by the afternoon. Safety Director Angie Vaughan reported she has finished the CPR training and commented on the great turnout. CDS Director Ken Hyndman stated the Regional Management Plan went thru MHDS Commission with a few changes. The Plan will be sent to DHS and should be approved. At the Region Governing Board meeting the finance committee discussed the pooling of funds, or further pooling of funds. We already pool funds for Risk Management. No decisions were made just conversation at the region level. Chief Deputy Jeff White also reported the Sheriff's Office non-emergency phone line was down. Jail Administrator Doug Ervine reported the jail had 74 inmates. Two correctional officers are now certified to teach CPR.

Correspondence: Received a letter from the City of West Burlington regarding an Urban Renewal Area Plan Amendment. A meeting to discuss the plan is set for February  $1^{st}$  at 10 AM at city hall. A public hearing is set for February  $15^{th}$  at 6 PM.

Lisa Walsh, Des Moines County representative, presented the Iowa Mississippi River Parkway Commission corridor plan. This is the 2015-2016 Annual Report. There are ten commissioners on Iowa's Commission. The national organization meets in the spring and fall and plan to meet this year in Lansing, Iowa. They worked with the Iowa DOT in implementing the new Iowa Byway Signage project. Two projects of concern in this area are Cascade Bridge in Burlington and the Montrose River Road in Lee County.

Jeff Hanan presented the Resolution and Final Plat for Shumaker Subdivision. Hanan stated this is a one-lot minor subdivision located in Danville Twp at 11841 Jimtown Road with a house and existing buildings. The lot is 10.50 acres owned by Sue Shumaker and Shumaker Farm LLLP & Trust. Hanan recommended approval. Cary motioned to approve. Broeker seconded.
