Mr. King explained that the purpose for doing just one lot now was that he had a purchaser and that would help pay for improvements to the rest of the subdivision. He said he's got a purchase agreement and that they intend to build a house within the next 4-5 years. Mr. Luckenbill asked about the driveway/driveway maintenance. Mr. King said that restrictive covenants within the subdivision would govern roadway/driveway maintenance. Fencing rules were also discussed. It was noted that the new owner would need to be aware of the fencing rules. Lori Blint asked about the driveway improvements that the county engineer is requiring and how that would affect their driveway. She was encouraged to coordinate with the new owner and the county engineer when it came time for the improvements.

waivers be submitted (or fence built per Subdivision Ordinance); and that the driveway to Lot 1 be
