The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, January 22nd, 2019 with Chairman Tom Broeker, Vice-Chair Bob Beck and Member Jim Cary present.

Changes to the tentative agenda: Remove items 11-15 & 17 CWA Contract proposal and response

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: Maintenance Supervisor Rodney Bliesener reported his department was busy over the weekend removing snow. He gave an update on the Jail Control Board, some wiring has been installed in preparation for the new control board. County Recorder Lisa Schreiner stated her office is continuing to scan documents into TCM. Public Health Administrator Christa Poggemiller reported her office is busy and the flu season is ramping up. Flu shots are still available. Sheriff Mike Johnstone reported on promotions and other personnel changes in the office. He also warned everyone to be careful due to incoming bad weather. Safety Director Angela Vaughan also warned everyone to be careful with weather conditions. Jail Administrator Doug Ervine reported the jail population is 84. CDS Director Ken Hyndman stated SEIL is working on next year's contracts by getting an early start. IT Director Colin Gerst reported his office is busy. County Attorney Lisa Schaefer reported she is busy and will be advertising for a new investigator and attorney. She attended the MLK Celebration at the Loft and stated is was very encouraging. Conservation Director Chris Lee stated the cold weather is creating some good ice but warned it is not thick enough to drive on and to be careful on any ponds and lakes. County Engineer Brian Carter reported the road crews were busy all weekend clearing snow. Rain is predicted this week and eventually turning to snow. Assistant Land Use Administrator Jarred Lassiter stated they are busy with a couple of subdivision reviews.
