The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, February 16<sup>th</sup>, 2021 with Chairman Tom Broeker, Vice-Chair Jim Cary and Member Shane McCampbell present. This meeting was held with limited capacity due to COVID-19 and electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meet with Department Heads: County Auditor Terri Johnson reported her office is busy and the last day to request an absentee ballot to be mailed for the Danville School Special Election is Friday, February 19th at 5PM. IT Director Colin Gerst stated his office is busy and the 3<sup>rd</sup> Floor Courtroom project is complete. They had some training with the court staff and judges on how to operate the system. Chairman Broeker thanked IT and Maintenance for all of their work on the project. County Engineer Brian Carter reported the Hwy 99 Bridge crew set five beams on the south span. The cold weather has slowed progress and the next set of beams to be set are the large center spans. Carter stated with all the snow, cold and wind winter weather people's patience has run out but winter has not. Carter thanked the road crew for their work over the weekend and the county received another 3" to 4" of snow last night and the salt supply is holding up well. Chairman Broeker commented about HF32 mentioned by Carter last week. He talked to Representative Kerr about this bill and Kerr stated this bill will not be going anywhere. Assistant Land Use Administrator Jarred Lassiter stated they are keeping busy and have several minor subdivisions out for review. Sheriff Kevin Glendening stated everything is going well and they have narrowed down the hiring process for two open positions. The current jail population is 84. CDS Director Ken Hyndman reported regional SEIL meetings were held last week. He reported an RFP was sent requesting proposals for someone to do assessments for each county. SEIRPC helped with the RFP and Optimae has been chosen to complete the assessments. Hyndman discussed the Mobile Crisis program which is available in a few counties but not in Des Moines County. He will be working on provider contracts starting in March thru June for next fiscal year. County Attorney Lisa Schaefer reported the new court system is being used today in a court case. She is very impressed with the new system which includes 2-75" TV's and 18 speakers. She thanked IT and Maintenance for all of their work on this project. She also thanked Maintenance for clearing the sidewalks around the office on President's Day. Chairman Broeker stated the County Attorney should be thanked for the new system by offering to pay for some of the equipment and applying for a grant. Local Health Administrator Christa Poggemiller reported her department is busy and the clinic held on Saturday at Memorial Auditorium gave 1,100 Covid vaccine shots. She stated there are less than 2,500 left on the wait list which at one time was over 4,000. 6,450 vaccines have been given in Des Moines County with 6,000 of those being county residents. She cannot schedule another clinic until more vaccine is received. The 7-day positivity rate is 6% with 68 new cases and the 14-day positivity rate is 8% with 105 additional cases. Total cases are 4,161. She thanked everyone for following CDC recommendations and encouraged everyone to continue following these protocols. Poggemiller received many good comments on how smooth the clinic ran. Via WebEx: County Treasurer Janelle Nalley-Londquist reported her office is busy.

Accounts Payable Claims in the amount of \$855,134.66 was presented. Cary motioned to approve and seconded by McCampbell.

Payroll Reimbursement Claims for 2/12 payroll in the amount of \$125.00 was presented. McCampbell motioned to approve and seconded by Cary.

Resolution and Final Plat for Steiner's Ridge Subdivision. Assistant Land Use Administrator Jarred Lassiter presented the subdivision. It is one-lot containing 7.61 acres lying west of Irish Ridge Road in the NE1/4 of Section 30 in Benton Township. Owner/Subdivider is Jeremy D & Brittny M Steiner, 16557 Irish Ridge Rd., Burlington. Lassiter recommended approval. Cary motioned to approve and seconded by McCampbell.

The 1st IDOT agreement addressed potions of Hwy 61 that will be turned over to the county after the Mediapolis Bypass is built. The county will receive two small portions of old Hwy 61 equaling about ½ mile. The 2nd IDOT agreement addressed four intersections of county roads to new Hwy 61 which the county agreement to pay a portion to be paved for access. The 3rd letter from IDOT addresses Covid-19 impacts to funding and relief funding allocation recommendations. Then the Board discussed the draft version of the 28E agreement with Lee County to provide mutual aid if needed for snow removal during the pandemic or other emergencies.
