The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, August 24th, 2021 with Chairman Tom Broeker, Vice-Chair Jim Cary and Member Shane McCampbell present. This meeting was held electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meet with Department Heads: County Auditor Terri Johnson gave an election update. The City of Burlington has four candidates running so far for city council. If they reach seven candidates, that will trigger a primary election. All candidates have until August 26th at 5:00 pm to file their paperwork. All city candidates file papers at the Auditors' Office, all school candidates file with the School District Secretary. Jerry Strauss is running for Mayor for the City of Danville with Ron Teater running for the City of West Burlington. County Attorney Lisa Schaefer reported her office remains busy with trials. She reported that the federally funded Victim Witness Grant they receive every year is being reduced by about \$2500. They have utilized the Child Protection Center in Muscatine for years and they recently lost their IDPH Grant and are going to start charging for services. Lisa is working with the Sheriff's office, as well as the Burlington Police Department to explore other options at this time. IT Director Colin Gerst reported his office is busy. Assistant Land Use Administrator Jarred Lassiter reported a minor subdivision is out for review. The Flood Plain Advisory Board has a meeting scheduled for this afternoon. He reports the office is staying busy. There is a work session scheduled for today. Conservation Director Chris Lee stated they have scheduled field trips for the fall. The staff is working on trails at Starr's Cave. Des Moines County Conservation will be holding a prescribed burning workshop on October 10th at Big Hollow. County Treasurer Janelle Nalley-Londquist stated her department mailed out the property tax statements Friday, August 20th. The DOT is in the office today to start the printer installation so there could be a delay, but they are working on them. Sheriff Kevin Glendening wants the public to be aware they have a subject that is being overly persuasive asking for money and being found in odd places on people's properties. Be aware that unfortunately those things do happen and if you feel intimidated, go inside, secure your property, and give the Sheriff's Office a call. The jail population is at 77. The Sheriff's Department has hired two new Deputies. Zander Schweiss and Jon Gates will be starting at the academy Monday August 30th and doing their field training for about four months following. County Engineer Brian Carter stated projects are moving along. Henry County is moving along with their project, so they are hoping the Geode project starts up in the next couple of weeks. He also wanted to remind everyone that school buses are moving again and to be safe. Public Health Director Christa Poggemiller stated that they continue to stay busy. Current Covid rate is 11% with 76 positive cases. They have given roughly 40,000 vaccines and continue to do drive through clinics and set up at local events to offer vaccines. Maintenance Supervisor Rodney Bliesener reported they have a bid open for the front steps of the courthouse. He would like to welcome the new Lead Maintenance Alex Schnedler. Safety Director Angie Vaughan stated the office is keeping busy. CDS Director Ken Hyndman reported they have been trying to get paperwork finished up for the funding requests which end August 31st.

Payroll Reimbursement Claims in the amount of \$380.00 was presented. Cary motioned to approve and seconded by McCampbell.

McCampbell motioned to approve the August 17th, 2021 meeting minutes and seconded by Cary.

Future Agenda Items: Conservation Director Chris Lee would like to present the Annual Report at the next meeting on August 31, 2021.

Committee Reports: Cary attended a Public Health and RUSS Meeting.

Meeting was adjourned at 9:32 a.m.

Two work sessions were held after the meeting. The first work session to discuss a subdivision roadway issue included Zach James and Jarred Lassiter with SEIRPC. Trent Henkelvig with the County Attorney's office was also present.

The second work session was to discuss planning of a new public health facility. Public Health Director

Christa Poggemiller presented reasonings for needing a new location to the Board of Supervisors. They also discussed a list of items needed in the new building to best accommodate the services offered to Des Moines County.
