IOWA ABSENTEE BALLOT REQUEST FOR JUNE 2, 2020 PRIMARY ELECTION

1. You are receiving this Absentee Ballot Request because you are a registered voter.
2. If you already submitted an Absentee Ballot Request, do not send another one.
3. If you want to receive a ballot by mail, the Absentee Ballot Request must be received by your County Auditor no later than May 22 at 5:00 PM CT.
4. You **MUST** be registered with either the Democratic or Republican party to receive a ballot.
5. This request is for the June 2 Primary Election only. Requests for the November General Election cannot be submitted until July 6.

STEPS TO REQUEST AN ABSENTEE BALLOT

- 1 To vote in the Iowa Primary, you **MUST** be registered as a member of either the Democratic or Republican party. Voters currently registered as "No Party" **MUST** update their voter registration by checking one of the party boxes in the "Primary Election Only" section of the form above. **Checking a political party box will update your voter registration if you are not already registered with that political party.**
- 2 Complete the attached Absentee Ballot Request and sign and date it. **You MUST be registered with a political party to receive a ballot, therefore you MUST check a political party box and sign the Absentee Ballot Request to receive a ballot.**
- 3 **Detach the completed Absentee Ballot Request and place it in the mail as soon as possible** to ensure time for your ballot to be mailed to you. The Absentee Ballot Request must be received by your County Auditor by May 22 at 5:00 PM CT if you want to receive a ballot by mail.
- 4 **Follow the instructions** to vote and return your ballot when you receive it in the mail from your County Auditor.
