Beck moved to approve the quarterly report of the Byar Estate Trust. The County receives over \$60,000 from this trust annually. Seconded by Broeker.

Beck moved to approve minutes for the Board meeting held on October 2, 2012. Seconded by Broeker.

During committee reports, Beck had attended a value added ag meeting.

Meeting was adjourned at 9:36 AM.
