The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, February 12th, 2013, with Bob Beck and Jim Cary present. Tom Broeker was absent.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: County Engineer Brian Carter asked for patience from rural residents. The area is having spring-like weather which caused gravel roads to become soft with potholes. Crews are putting gravel in places but supply of rock is not sufficient to put on every road. When temperatures drop and the roads firm up again, they will be bladed. CPC Ken Hyndman reported that there will be a meeting on February 25th for supervisors from the seven counties that are considering forming a Mental Health region to discuss and sign an agreement. This meeting will be held at the Louisa County Sheriff Complex. City/County Safety Director Angie Vaughan complimented the Sheriff's department for conducting the ALICE training.

John Bentler, Chairman of the Des Moines County Compensation Board, presented their recommendations for salary increases for the eight elected officers. David Walker and Richard Mellinger, members of the Comp Board, were also present. Bentler explained the process used to calculate the proposed increases. The Board accepted the recommendations without comment.

Land Use Administrator Jeff Hanan presented a Resolution and Final Plat for Spring Lake Subdivision. He stated that this is a one lot subdivision with an existing house. Cary moved to approve. Seconded by Beck.

County Attorney Pat Jackson is applying for a Crime Victim Witness grant in the total amount of \$90,000 and asked the Board to sign a letter of support. Motion to approve was made by Cary and seconded by Beck. The money will be received over three years.

The Sheriff's report of fees collected in January, 2013, was received and filed:

The minutes for February 5th were removed from the agenda. Beck was not present last week and Broeker is absent today.

During committee reports, Cary had attended a state-wide meeting of County Supervisors in Ames. Beck attended a meeting of D-Cat and the Chamber of Commerce annual meeting.

Meeting was adjourned at 9:38 AM.

A work session was held regarding the 2013/2014 County budget. The Supervisors have decided to borrow \$1.5 million in order to pay for capital projects during the next three fiscal years. The proceeds of the bond will be put in the General Basic fund to give it a healthy balance. Budget Director Cheryl McVey reported that if the cities of Burlington and West Burlington implement a franchise tax on utility payments, the County will lose \$130,000 per year in sales tax revenue.
