The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, March 18th, 2014, with Bob Beck, Jim Cary and Tom Broeker present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: County Engineer Brian Carter reported that crews are applying rock in soft spots on gravel roads. Sheriff Mike Johnstone has been hearing requests from rural residents for an evening meeting in one of the small towns and asked the Board to consider it. Chris Lee, Conservation Director, reported that the primitive cabin at Big Hollow is available for reservations for \$25 per night with a 2 night minimum. CPC Ken Hyndman advised the Board of several upcoming meetings. At the regional meeting on Friday, it will be decided which Supervisor will be chair of the district and which county will be fiscal agent. The regional plan must be sent to the State by April 1st.

The following correspondence was received:

Beck read a Proclamation for the 100 year anniversary of County Extension.

Accounts Payable Claims in the amount of \$352,858.67 were approved upon motion made by Cary and seconded by Broeker.

A law enforcement agreement with the City of Middletown was presented for approval. Sheriff's deputies will patrol this city not less than six hours per week. Middletown will pay the County \$20,956.08 in monthly installments of \$1,746.34. A law enforcement agreement with the City of Mediapolis was presented for approval. Sheriff's deputies will patrol Mediapolis not less than 24.5 hours per week. Mediapolis will pay the County \$85,570.08 in monthly installments of \$4,130.84. Chief Deputy Jeff White stated that these contracts were for the same hours of service as last year with a three percent increase in rates. Broeker moved to approve both contracts. Seconded by Cary.

Cary moved to approve a Class B Beer license for 34 Raceway, Inc. Broeker seconded, stating that he had checked with both the Sheriff and Public Health Director and they had no problem with this license.

The Auditor's office submitted a list of bids dated from 1983 through 1999 that can be destroyed. The Auditor explained that bids had been retained forever but that law was amended to allow destruction of bids over ten years old. The County Engineer and the Maintenance Supervisor went through the bids and kept all that had historic value. Motion to approve the shredding of remainder of these documents was made by Broeker and seconded by Cary.

At the Correctional Center, part time C O Brandon Knouse resigned effective March 1, 2014. Shelby Standard was hired effective March 18, 2014 as part time C O. Motion to approve these actions was made by Broeker and seconded by Cary.

The following reports were received and filed: Sheriff's Report of Fees Collected, February 2014 Correctional Center, February 2014

Broeker moved to approve minutes for the Board meeting held on March 11th, 2014. Seconded by Cary. Future agenda items: on March 25th a public hearing will be held to sell county property located on Lewis Street. The Engineer will take the Board on a project tour in the afternoon.

During committee reports, all members had attended ISAC meetings and Capital Day in Des Moines. Meeting was adjourned at 9:34 AM.
