## August 19, 2014

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, August 19th, 2014, with Bob Beck, Jim Cary and Tom Broeker present.

Unless otherwise noted, all motions carried.

Meet with Department Heads: County Engineer Brian Carter reported that secondary roads crews will be hauling salt for the next several days. He has purchased 1,800 tons of treated salt and it was delivered by river barge. Carter also met with Mediapolis City Council regarding improvements to Mediapolis Road. The County and City are working on a 28E agreement spelling out areas of responsibility. County Attorney Amy Beavers attended the Danville City Council meeting last night. She will be participating with the Burlington Police Department on the Neighborhood Watch program. Cary relayed a compliment from a passport customer to County Recorder Lisa Schreiner. Community Services Director Ken Hyndman reported that his office will be closed most days from noon to 1 PM due to reduced staffing.

Under correspondence, the Board discussed a neighborhood conflict about a fireworks permit issued last week. They had received several phone calls and emails from both parties.

Accounts Payable Claims in the amount of \$526,064.57 were approved upon motion by Cary and second by Broeker.

At County Conservation, Dilan Beaird was changed from part time summer intern to seasonal part time Conservation Technician. Broeker moved to approve. Seconded by Cary. This change takes effect August 26, 2014, with no change in rate; \$9.50 per hour.

The Sheriff's Monthly Report for July 2014 was received and filed.

Broeker moved to approve minutes for the regular Board meeting held on August 12<sup>th</sup>, 2014. Roll-Call Vote, Broeker, Aye Cary, Aye Beck, Abstain

Committee reports: Broeker attended a SEIL Governance Board meeting and a Grow Greater Burlington meeting. He reported that retail sales are up 5.1% and employment numbers are up 650 people since June 2013. Cary attended a RUSS meeting where a Resolution for service in Mooar and Powdertown, Lee County, was approved. Beck attended a Conservation Board meeting and gave testimony at a DOT meeting regarding construction of a fourlane Highway 61.

Meeting was adjourned at 9:30 AM.
