The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, February 17th, 2015, with Jim Cary, Tom Broeker and Bob Beck present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: County Engineer Brian Carter stated that crews were cleaning ditches and tearing out a bridge. Conservation Director Chris Lee responded to criticism of his department in a newspaper article about the annual audit. The Auditor had been quoted that a budget amendment was necessary for Conservation when actually it was a capital project expenditure for the bike trail. The budget amendment for that expenditure was not done before payment was remitted.

Accounts Payable Claims in the amount of \$373,300.39 were approved upon motion by Broeker and second by Beck.

Beck moved to approve the Weed Commissioner's report for 2014. Seconded by Broeker.

Dan Allen was appointed to a four year term as Concordia Township Trustee. Beck moved to approve. Broeker seconded.

The following personnel actions were approved: at the Sheriff's Office; Monika Ryan was hired as part time clerical effective February 23, 2015. Her rate is \$12.50 per hour. Deputy Alfred Waterman received his anniversary increase. Beck moved to approve both actions. Seconded by Broeker. In the Treasurer's Office; Ashley Sherwood, Clerk II, took leave without pay. Approved upon motion by Broeker and seconded by Beck.

The following reports were received and filed:

Case Management, January 2015 General Assistance, January 2015

Broeker moved to approve minutes for the Board meeting held on February 10th, 2015. Seconded by Beck.

Future agenda items: the Board will hold a work session next week regarding the cost saving report.

During committee reports, Broeker had attended meetings of the MHDS Board of Governance and Greater Burlington Partnership. Beck had attended Southeast Iowa Days where he lobbied for the widening of Highway 61. Cary had attended a RUSS meeting. The exit agreement has been forwarded to the three counties that want to withdraw from the organization. An appeal is in process for \$21,000 in back dues. \$6,000 has been awarded from another lawsuit and has been applied to the RUSS bill with Mt. Union.

Meeting was adjourned at 9:27 AM.

A work session with the Sheriff and Jail Administrator was held following the meeting. The topic was a proposed pay schedule for a new Jail Administrator and Assistant Jail Administrator. The proposal will save approximately \$30,000 over a three year period. It was agreed to accept the pay schedule and evaluate it in the future if staffing would change.
