The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, March 1<sup>st</sup>, 2016, with Tom Broeker, Bob Beck and Jim Cary present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: the County Auditor announced that ballots are now available for the West Burlington School Special Election. The election will be held on April 5<sup>th</sup>. County Engineer Brian Carter reported that crews are working on Irish Ridge Road, disking the shoulders to improve drainage. The first layer of rock will be hauled today. Work is also being done on other gravel roads in the county. Conservation Director Chris Lee reported that he has been working on the Land & Water grant application. It will be brought to the Board next week. Lee also stated that the Corps of Engineers are working on Huron Island and are staged at Hawkeye-Dolby landing. The boat ramp might be unavailable at times. Land Use Administrator Jeff Hanan stated that there is still an opening on the Board of Adjustment. The applicant must live within the two mile limit of Burlington. Interested persons can apply to Hanan at SEIRPC or to the County Auditor.

Beck moved to approve Accounts Payable Claims in the amount of \$277,160.35. Seconded by Cary.

Hanan presented the Resolution and Final Plat for Hammje Subdivision. Hanan stated that this is a three lot subdivision in Jackson Township. Two lots will be sold to Two Rivers Levee & Drainage District immediately. After the Hammje's vacate the dwelling, the third lot will also be conveyed to Two Rivers. Hanan recommended approval. Beck moved to approve. Seconded by Cary.

Carter also presented the Engineer's report on bid results for the Madison / Glenmark RCB Culvert project LFM-P1-16—7X-29. On this project, Iowa Bridge & Culvert of Washington, IA was the low bidder at \$144,987.40. The contracts will be signed later.

Motion to approve all actions was made by Beck and seconded by Cary.

Future agenda items will be the public hearing for FY17 County Budget on March 8<sup>th</sup>, public hearing for the G O Bonds on March 15<sup>th</sup> and a project tour with the County Engineer on March 29<sup>th</sup>. Chris Lee asked the Supervisors to join in tours of Conservation construction projects. These will be conducted on various days.

During committee reports, Broeker had attended an Emergency Management exercise last week.
