The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, May 24<sup>th</sup>, 2016, with Tom Broeker, Bob Beck and Jim Cary present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: the County Auditor reported that her office has sent 96 ballots for the Primary Election and received 58 back. Her office will be open on Saturday, June 4<sup>th</sup>, for early voting. The last day to vote in the office is Monday, June 6<sup>th</sup>. The office will be open until 5PM. County Engineer Brian Carter reported that the Pleasant Grove Road project was done last week but one lane past Big Hollow is closed for patching. The contractor has begun work on Highway 99 and has completed almost 4 miles. Milling and patching on Memorial Park and Plank Roads is being done prior to applying a new asphalt surface. Conservation Director Chris Lee stated that he now has a full staff of seasonal workers. The campground brought in \$2,000 in revenue last week. Next weekend is free fishing and camping and bike trails weekend. Christa Poggemiller, Director of Local Health, announced that the clinic will be closed on May 30 and June 3 due to reconstruction of the front entrance of the Health Department. Janelle Nalley-Londquist, County Treasurer, attended her affiliate's summer school last week. There will be some rule changes for the motor vehicle department. CDS Ken Hyndman stated that he has been working with contracts for providers in the SEIL region. The second Mental Health Advocate will be starting work next week. She will serve Jefferson, Lee, Van Buren and Keokuk Counties.

Land Use Administrator Jeff Hanan presented the Resolution and Final Plat for Lane-Smith Subdivision, a one lot minor sub in Yellow Spring Township. Hanan recommended approval. Cary moved to approve. Seconded by Beck.
