The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, August 9th, 2016, with Bob Beck and Jim Cary present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: Deputy Auditor Terri Johnson gave an update on the General Election. The candidate filing period for Nominated by Petition candidates started August 8th and will continue thru August 31st. Several Township Officers have already filed papers. Absentee ballot requests for the General Election are over eleven hundred. County Engineer Brian Carter reported on road projects. The North Gear/Flint Bottom Road project has started and pavement has been removed. The Madison Avenue project is still on hold due to utility company issues. County Recorder Lisa Schreiner stated their office is in the process of repairing index books. The project is almost complete. They are still working on the microfilm digitizing process. Safety Director Angie Vaughan stated she is scheduling CPR Training, Active Shooter Training and Railroad Training. Jail Administrator Doug Ervine reported they have fifty-four occupants.

Correspondence: Received a letter from Great River Medical Center regarding a loan agreement between Des Moines County and Great River Medical Center. The borrower agreed to annually on or before August 15th of each year to furnish the issuer with a statement of the principal amount of the Bonds outstanding as of June 30th. Their records indicate the principal amount of the Health Facilities Revenue Bond, Series 2012A was \$28,666,666.67 and the outstanding principal amount of the Health Facilities Bonds, Series 2012B was \$15,087,719.30 as of June 30, 2016.

During public input session one – Sam Larson, 10671 Memorial Park Rd, Burlington commented on the Memorial Park Rd and Plank Rd paving. He appreciated the newly paved roads.

Jeff Hanan presented the Resolution and Preliminary Plat for King's Country Estates. Hanan stated this is a thirteen lot subdivision in Huron Township. A waiver was requested from Article V Section 2.3 to allow a cul de sac greater than 1,000 feet in length. The waiver was approved by emergency agencies. The Zoning Commission recommends approval. Cary moved to approve. Seconded by Beck.

WHEREAS, it has been several years since the compensation rate has been increased, and

NOW, THEREFORE, BE IT RESOLVED, by the Des Moines County Board of Supervisors, that effective September 1, 2016, Precinct Election Chairs receive ten dollars (\$10.00) per hour and Precinct Election Workers receive eight dollars and fifty cents (\$8.50) per hour per election.
