The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, December 20th, 2016, with Bob Beck and Jim Cary present. Tom Broeker was absent.

Unless otherwise noted, all motions carried.

Meet with Department Heads: County Engineer Brian Carter reported that roads are in decent shape. Crews were out removing snow and ice over the weekend.

Accounts Payable Claims in the amount of \$655,403.91 were approved for payment upon motion by Cary and second by Beck.

Cary moved to approve the taxable payroll claims reimbursements in the amount of \$1,478.20. Seconded by Beck.

Jeff Hanan presented the Resolution and Final Plat for Rabbit Hollow Subdivision. Hanan stated that this is a subdivision owned by Dan Peterson and located in Franklin Township. It had been approved by the Supervisors on October 4th, 2016, but some minor changes were made since. Hanan recommended approval. Cary moved to approve. Seconded by Beck.

WHEREAS the Final Plat for **Rabbit Hollow Subdivision** has been reviewed for conformance to applicable County standards by the Des Moines County Health Department, Secondary Roads Department, County Auditor, Zoning Commission Chair and Land Use Department and has been duly recommended by the aforementioned entities for approval,

NOW THEREFORE, BE IT RESOLVED: That the Board of Supervisors hereby approves the Final Plat of **Rabbit Hollow Subdivision**.

Beck read a Resolution allocating Des Moines County funds to the Reserve Fund of County Conservation for capital improvements and spelling out the repayment agreement. Cary moved to approve, stating that the Conservation Board's plans will be a big improvement to Big Hollow and attract more people. Beck seconded, adding that it will also bring in more revenue. The funds will be used to build a shower house and a dump station among other amenities. Chris Lee, Director of County Conservation, thanked the Board for their support.

RESOLUTION ALLOCATING DES MOINES COUNTY, IOWA FUNDS TO RESERVE FUND OF DES MOINES COUNTY CONSERVATION FOR CAPITAL IMPROVEMENTS AND REPAYMENT AGREEMENT

WHEREAS, the Des Moines County Conservation Department plans to construct a Recreational Vehicle (RV) dump station, shower house and associated infrastructure constituting capital improvements at the RV campground

at Big Hollow Recreation Area, and

WHEREAS, the Des Moines County Conservation Board requests that the Des Moines County Board of Supervisors allocate funds to the conservation reserve fund for such capital improvements, and

WHEREAS, the Des Moines County Conservation Department plans to collect funds in the form of user fees, grants, and donations to be allocated toward the aforementioned improvements in the coming years, and

WHEREAS, the Des Moines County Conservation Board agrees to reimburse the County's General Fund in the amount of \$250,000.00 by way of five (5) annual payments of at least \$50,000.00 each on or by June 30 of each year commencing June 30, 2018, to be paid from the aforementioned Conservation Department-generated revenues, with full reimbursement to be completed by the close of fiscal year 2022, and

WHEREAS, the Des Moines County Board of Supervisors desires to preserve the integrity of funding the actions and programs of the Des Moines County Conservation Department, and

WHEREAS, it is the intent of the Des Moines County Board of Supervisors to allocate \$250,000.00 from the County's General Basic Fund to the Conservation Department in fiscal year 2017 so that the Conservation Department may construct said improvements as one single project in 2017, and

WHEREAS, the appropriation of said funds to the Conservation Reserve Account is permitted and is being requested in accordance with the provisions of Iowa Code Section 350.6.

NOW THEREFORE BE IT RESOLVED, the Des Moines County Board of Supervisors hereby executes this funding agreement and formally encumbers the annual reimbursement amounts noted for the time period specified.

Tom Broeker was re-appointed to serve on the Joint Safety Committee. Motion was made by Cary and seconded by Beck. This is a one year term.

The following Township Trustees were appointed to four year terms: Michael D. Miltenberger, Danville Township, Wayne Heibner, Flint River Township and Kirk Honson, Franklin Township. Motion was made by Cary and seconded by Beck.

Joel Behne was presented with a 25 Years of Service Award. Behne is currently the office manager at County Conservation and had served as County Sheriff for 12 years.

The following personnel actions were approved: at the Sheriff's office, Mary Beik was promoted to Clerk I, effective January 1, 2017. Her new salary will be \$34,575.41 annually. Cary moved to approve. Seconded by Beck. At the Correctional Center, Tamara Hulett, FT Correctional Officer, took 6 days of unpaid leave. Angela

Schertz and Alexis Stephenson were hired as PT Correctional Officers. They will be paid \$10.77 per hour. Motion to approve these actions was made by Cary. Beck seconded.

Cary moved to approve minutes for the Board meeting held on December 13th, 2016. Seconded by Beck.

Future agenda items: a work session with the County Attorney, Sheriff and Public Health regarding an issue dealing with dog packs in rural areas will be held on January 3, 2017.

Committee reports: Cary attended a meeting of the Eighth Judicial District in Fairfield. He attended a RUSS meeting where it was discussed shutting off more utilities in Ollie and Mt. Union. Cary also attended meetings of SE Iowa Crime Commission and Juvenile Detention. Beck attended meetings of the Des Moines County Board of Health and DeCat.
