January 3, 2017

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, January 3, 2017, with Chair Bob Beck, Vice-Chair Jim Cary and Member Tom Broeker present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: Auditor Terri Johnson reported the budget hearing schedule has been set and the hearings will start January 10th. Conservation Director Chris Lee introduced his new office manager, Jeff Breuer. Safety Director Angie Vaughan reported she is still conducting CPR training. She will have trained 250 employees when completed.

Richard Benne, 2125 Sunnyside Ave, Burlington received an old bridge plaque from the Secondary Roads Department. The plaque was on a bridge demolished years ago on 154th Ave. The bridge was built in the early 1900's and listed Henry Benne as a county supervisor. Henry Benne was his Great Great Grandfather. He was grateful for the plaque and wanted to thank the roads department.

Accounts Payable Claims in the amount of \$567,660.69 were approved upon motion made by Broeker. Cary seconded.

Taxable Payroll Claims reimbursements totals were approved upon motion by Broeker. Cary seconded.

Dan Cahill, Des Moines County Compensation Board chair, presented the 2017/2018 Salary recommendations for the elected county officials. Compensation board members Duane Worthy and Charlie Walsh were also present. Cahill detailed how the Compensation Board determined the salary increases following Iowa Code Section 331.907. They compared salaries from ten counties with similar size to Des Moines County. They recommended a 2% increase for the County Attorney, Recorder and Sheriff. A 3% increase for the County Auditor and Treasurer. The Board of Supervisors would receive a 0% increase since their salary is in the range for the ten counties average. The raises would cost the county \$8,889 for the eight elected officials. Deputy salaries would also be affected. The Board thanked the Compensation Board for their work. Broeker moved to accept the recommended raises as presented by the Compensation Board. Cary seconded.

County Engineer Brian Carter presented an Iowa Department of Transportation Federal-aid Agreement HMA Surfacing Project STP-S-CO29(83)—5E-29 for Beaverdale Road, Mediapolis Road, 205th Ave and 260th Street. HMA is a hot mix asphalt overlay. This agreement is standard federal paperwork and is a project that has federal funding in it but it is not the only funding. The agreement will allow them to work on the plans for the project. They plan to bid this project next winter for the following year's construction. Cary moved to approve the agreement. Broeker seconded.

J & M Displays, Inc. submitted an application for a yearly fireworks permit for product testing. Broeker moved to approve the permit. Cary seconded.

Jeff Hanan, SEIRPC submitted a resolution to reappoint Ron Breuer to the Des Moines County Zoning Commission. His term will expire January 2022. Broeker moved to approve the reappointment. Cary seconded.

They will be moving their offices to the hospital and working on the agreement. There is a possibility of including more counties and municipalities by working out of one office.

Everyone present reviewed the ordinance provided by the County Attorney. Definitions and dangerous animal species were discussed. The role of the Animal Control Board was discussed and possibly adding a criminal animal ordinance. The Sheriff stated he needed an ordinance that could be backed up and did not want to be the control agency. Changes were requested and another work session will be scheduled in three weeks. It was suggested to include veterinarians and the animal shelter to the next meeting.
