September 19th, 2017

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9:00 AM on Tuesday, September 19th, 2017, Bob Beck, Jim Cary and Tom Broeker were present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: County Auditor Terri Johnson reported the Regular City Election candidate filing deadline is Thursday, September 21st at 5:00 PM for the cities of Danville, Mediapolis, Middletown and West Burlington. Public Health Administrator Christa Poggemiller reported they are working on setting up flu clinics for the various departments. County Engineer Brian Carter stated with the little bit of moisture received from the fog, his crews will be blading the roads. They are working on various projects and will start the low water crossing project soon. Chief Deputy Jeff White reported yesterday's jail population was 104. They are down to 100 today. They are talking to a fourth county for additional jail space. Community Services Director Ken Hyndman attended a SEIL Stakeholder meeting last week. It was well attended and they discussed how to assist difficult to serve people with mental health and disability issues. Their goal is to create Community Based Services to meet the needs of individuals here. It all depends on adequate funding. He attended a SEIL Governors Board Meeting. They discussed Senate File 504 and starting July 1, 2021, the state will limit the Region to a 20% fund balance. County Treasurer Janelle Nalley-Londquist reported her office is busy collecting property taxes. County Recorder Lisa Schreiner reminded the public it is time to renew recreational vehicles license, they are due December 31st.

Cary motioned to approve Accounts Payable Claims in the amount of \$544,155.52. Broeker seconded.

The Treasurer submitted a letter listing Treasurer's checks that are outstanding for more than one year as of June 30^{th,} and hereby cancelled. The total of \$22.00 will be deposited into the General Basic fund. Broeker motioned to approve. Cary seconded.

The IDOT Preconstruction Agreement for Flint River Trail funding for Primary Road Project was reviewed. Conservation Director Chris Lee discussed the trail. The trail will go under the new Hwy 61 Flint River Bridge and back up onto the highway. The State is picking up the creation of the trial crossing the bridge. The agreement requires a local match of \$100,000 for a \$500,000 project. Broeker motioned to approve. Cary seconded.

Maintenance Supervisor Rodney Bliesener presented a letter of understanding between Des Moines County and Bridgeway, Inc to provide janitorial services for the offices of the Des Moines County Sheriff, Public Health Department and County Attorney. Terms of agreement are from October 1st, 2017 to September 30th, 2018 in the amount of \$23,013.17 yearly, \$1,917.76 monthly. Broeker motioned to approve. Cary seconded.

The following Personnel Action was approved: Sheriff's Office – Robert Kirby Corrick, Courthouse Security new hire. The new rate is \$16.66 hr., effective 9/1. Cary motioned to approve. Broeker seconded.

The following reports were received and filed in the Auditor's Office: Clerk's Report of Fees Collected, August 2017 Recorder's Report of Fees Collected, August 2017

Cary motioned to approve the minutes for the Board meeting held on September 12th, 2017. Broeker seconded.

Committee Reports: Broeker attended a Flood Plain Management Seminar on FEMA and DNR regulations. He also attended the following meetings: a SEIL Stakeholders Meeting, a SEIL Advisory Board meeting where they discussed problems for service providers, and a SEIL Governor's Board meeting where they approved claims and discussed Crisis Intervention Training (CIT) rules. He also attended a DHS Region CEO meeting last Thursday in Des Moines with the Budget Director where they discussed MHDS budgets for 2020. Cary attended a Southeast Iowa 8th Judicial District meeting. Beck attended a Chamber meeting and a DeCat meeting.

Public Input Session #2: Several individuals attending the meeting addressed the Board regarding Title X Family Planning Services in Des Moines County. Reverend Don Henry, Flint Hills Church of the Nazarene was

unable to stay for the work session following the meeting and wanted to reemphasize the value of a human life when considering the Title X provisions. Laura Blanchard, 1 Concord Dr., stated she was a former patient of Planned parenthood and a member of Southeast Iowa Progressives. She has started an online petition to get a Title X Clinic off the ground and has received over 300 signatures and comments. She stated there is a public health crisis in our county with 2100 patients left without care after the closing of the Planned Parenthood Clinic. She asked the Board not to pass the buck and fiscally responsible health care is cheaper. Phoebe McNeece, 124 Melrose Ct., was a Planned Parenthood patient. She has to go outside the county to Iowa City to receive the same services she received at Planned Parenthood. She stated she is foregoing health care because she cannot make the trip to Iowa City. Diane Lerud-Chubb, 2429 Gnahn St., was on the Planned Parenthood Board for the Heartland before the merger. She stated individuals lost affordable and accessible health care. Southeast Iowa has the highest unwanted pregnancies in the State. Individuals with limited income need services provided in this area, not seventy to eighty miles away. Dennis Kuster, 114 Grand St., stated since Planned Parenthood closed there are holes not being covered by hospitals for coverage. Especially for economically disadvantaged people.

Meeting adjourned at 9:32 AM.

Following the meeting was a work session with the Board and Public Health Administrator Christa Poggemiller present to discuss Title X Family Planning Services. Poggemiller distributed a proposed budget for the Title X Clinic. The proposed clinic was started as a community effort after Planned Parenthood was closed. The Board of Health felt there was a gap in services not provided elsewhere to address women's and men's health issues. The budget presented was based on projections in six month increments. The budget did not include a line item for the clinic location. She stated the revenue and expenses would be neutral after the first year and GRHS would donate unused equipment. Cary asked about staffing and cost. Several residents spoke in favor of the clinic and encouraged the Board to apply for the grant providing funds. The Board had researched Planned Parenthoods revenue and expenses from three older IRS Tax returns. About half of their revenue came from donations, which the County does not expect to receive or continue. Any clinic funding would come out of General Basic funds and they felt it could greatly increase the levy for property owners.

Following the above work session, the Board and County Engineer took a road tour.
