December 19th, 2017

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9:00 AM on Tuesday, December 19th, 2017. Present were Chairman Bob Beck, Vice-Chair Jim Cary and Member Tom Broeker.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: Sheriff Mike Johnstone gave an update on the December 10th jail situation. He stated he has reviewed the video and very proud of the jail employees in their response. He was exceptionally proud of correctional Officer Darlene Fox for protecting the injured correctional officer from further harm. The response from other entities was unbelievable. The jail is a direct supervision jail and need to find ways to make the jail a safer place. Overcrowding is an issue with the number of correctional officers available. More details for changes will be discussed during the work session this afternoon. Maintenance Supervisor Rodney Bliesener stated his department has reviewed their policy for maintenance at the jail. He appreciates the jail staff for working with him. Conservation Director Chris Lee reported the footings have been poured for the new shower house. CDS Director Ken Hyndman reported he attended the SEIL Change Agent, Advisory and Governing Board meetings last week. They discussed the Managed Care Organization (MCO), departure of AmeriHealth Caritas on November 30th, the new tiered rate system starting for the Intellectual Disabilities (ID) waiver. Providers are nervous about the changes. MCO – United Healthcare is doing more in-house case management and will likely negatively affect Integrated Health Homes (IHH's) soon and Amerigroup is expected to bring all case management in-house. Southeast Iowa Case Management closes at the end of December and Area Agencies on Aging will no longer be doing case management. Loss of these entities will put more pressure on the region to develop another way of getting individual assessments done. Budget projections for FY19 will be more difficult this year as legislative changes are being considered to add more core services to the list regions must provide. There is the possibility of regions having to pick up more services that Medicaid used to pay for. The SEIL Finance Team will bring possible scenarios to the Governing Board to consider at the January meeting. Derrick Dufresne is coming to SE Iowa in February to bring Five Star Quality training to providers. The SEIL region is having C3 De-escalation training in January. These are train-the-trainer events. They would also like to see a National Alliance on Mental Illness (NAMI) chapter in our region.

Accounts Payable. Cary motioned to approve accounts payable claims in the amount of \$524,576.12. Broeker seconded.

Payroll Claims Reimbursements. Broeker motioned to approve payroll claims reimbursements in the amount of \$1,294.60. Cary seconded.

Award Flint River Trail Contract for Project: TAP-R-CO29(076)—8T-29. Conservation Director Chris Lee stated this project was the end portions of the trail section thru the Starr's Cave Preserve. The two ends are from Irish Ridge to the Nature Center and the end of the preserve section to Highway 61. The Center portion was previously awarded. The contract will be awarded to Absolute Concrete Construction, Inc in the amount of \$229,960.97. Broeker motioned to approve the contract. Cary seconded.

Appoint Conservation Board Member. The Board received five letters of interest for the position and they were all good applicants. Cary read current Conservation Board member Jim Garnjobst letter of support for Bob Hansen. Cary motioned to appoint Bob Hansen to the Conservation Board. Broeker seconded.

Appoint Veterans Affairs Commission Member. Ron Siegel submitted a letter of interest to be reappointed to another three-year term. Broeker motioned to re-appoint Ron Siegel to the Veterans Affairs Commission. Cary seconded.

Compensation Board Recommendations. The Compensation Board recommended a proposed increase of 3% for all elected officials. Cary stated he felt the elected officials should receive the same raise as the union contracts. Cary motioned to approve a 2.25% increase for all elected officials. Broeker seconded.

Personnel Actions: Local Health – Kaylee Dochterman, Part-time CNA. New hire - rate is \$12.63 hr., effective 12/18. Broeker motioned to approve. Cary seconded.

Reports. The following report was received and filed in the Auditor's Office: General Assistance Report, November 2017

Board Minutes: Broeker motioned to approve the minutes for the Board meeting held on December 12th, 2017. Cary seconded.

Future Agenda Items: Work session early next year between Harmony Bible Church and County Assessor regarding taxes on property at 550 Division St., Burlington.

Committee Reports: Broeker attended the SEIL Mental Health Region meeting including the Governance Board meeting. They are starting on the budgeting process and discussed the problems with MCO's. Cary attended a RUSS meeting and things are going smoothly. Their sewage pump truck is working well and business is picking up. He attended a Southeast Iowa Crime Commission meeting and stated they will receive a rebate of \$8,825.04. He also attended a Juvenile Detention Meeting. July thru November 2017 has seen juvenile detentions use 417 days @ \$160 a day in costs. During the same time frame from July thru November 2016 juvenile detentions used 300 days @ \$160 a day. So far, this year this has cost \$18,837 more than last year and this does not include transportation or medical care costs. Beck attended a Trail meeting.

Meeting adjourned at 9:46 AM.

A work session followed the Board meeting between the Board of Supervisors and County Engineer Brian Carter. The county Engineer gave the Board an update on the Flint Creek Bridge (T-29) construction project. He stated the consultant is making head way. The studies have been done and a preliminary set of plans was submitted to the DOT last week. The new bridge will be 40' wide and slightly higher than the current bridge. Start of construction could start next year but most likely will be the following year. When construction starts the road will

be closed to traffic. The County Engineer met with the Levee District, he stated it was a good meeting and they are trying to be as minimally invasive as possible on the levee.

Department heads and elected officials met at Starr's Cave Nature Center for a budget meeting.

A work session between the Board of Supervisors, Jail Administrator and County Sheriff took place at 1:30PM. Several were in attendance for the work session to discuss recent issues at the Jail. The Jail Administrator recommended several options to help alleviate some of the issues. Option A: Need a 40+ bed addition with more staffing and split the general population in half with a full height wall. The current 30 beds section would be split down the center to separate the current beds and become a 16/14 unit. Option B: Split general population in half with a wall and create a 16/14 unit and increase the Correctional Officer shifts – 5 minimum on 1st shift, 5 minimum on 2nd shift and 4 minimum on 3rd shift (inmates are on lockdown during this shift). Other items discussed: the Jail Administrator would like to bring in James Estes & Associates for a Jail assessment. The Sheriff stated more staff is needed, the current staff is doing minimal day to day events because they are busy doing all other necessary duties as required. The Board requested staffing change and dividing wall costs. An expansion will require documentation with to show the increase in inmates and the cost to house inmates in other counties. The Jai Administrator and Sheriff will put together this information and present it at the next Board of Supervisors meeting.
