The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, August 21st, 2018 with Chairman Jim Cary, Vice-Chair Tom Broeker and Member Bob Beck present.

Changes to Tentative Agenda: Work Session with Washington National Supplemental Benefits was removed and will be rescheduled in September.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: County Auditor Terri Johnson reported on August 13th the Auditor's Office began accepting Passport Applications. The candidate filing deadline for the General Election is August 29th at 5:00 p.m. Due to the recent LULAC injunction, absentee voting will begin 29 days before the election on October 8th and absentee request forms do not require a voter to include a voter verification number. County Treasurer Janelle Nalley-Londquist stated her office is busy. Approximately 28,600 tax statements were mailed last Friday. She thanked her staff for their efforts in the process. County Engineer Brian Carter reported Beaverdale Rd / Washington Rd intersection may open tomorrow, including the ramps. He appreciated everyone's patience. Flint Bottom Road may close in late September due to the Hwy 61 expansion project. The patching crew is working on Beaverdale Rd. then to Mediapolis Rd. He will push back the Flint Creek Bridge project to bid next year. They have the DNR permit but they do not have the Corps permit. The Levee District needs to submit a letter of support for the project to the Corps. The south end of the Iowa City Rd project is on hold due to a utility holdup. Conservation Director Chris Lee reported the Flint River Trail project will be completed at the end of September and the trails will be closed until then. Approximately 100 people attended the Summer Celebration Event at Starr's Cave Nature Center. Conservation was approved for the Wellmark Grant for the Big Hollow playground equipment. The project construction should start in four to six weeks. County Attorney Amy Beavers stated her office is busy. They have three District Court jury trials this week. She reminded everyone schools are back in session soon and beware of children walking to school and school buses. The County Attorney's Collection Program has collected approximately \$120,000 in unpaid fines and court costs. This does not include money back to the County or State. They are starting a program to fund school lunches for all school districts in Des Moines County for those unable to pay for lunches. Safety Director Angie Vaughan stated her office is busy with emergency preparedness training and silica training to discuss the hazards of working around silica dust. She also stated we are three months accident free. Chief Deputy Jeff White also wanted the public to be aware that schools are back in session. Jail Administrator Doug Ervine reported the jail population at 99. Others present were Maintenance Supervisor Rodney Bliesener, IT Director Colin Gerst and Assistant Land Use Administrator Jarred Lassiter.

Accounts Payable Claims in the amount of \$2,395,384.95 were approved upon motion made by Beck and seconded by Broeker. It was noted \$1.5 million was paid to the SEIL Region for Mental Health.

Payroll Reimbursement claims in the amount of \$2,235.00 and non-cash taxable reimbursement in the amount of \$60.00 were approved upon motion made by Broeker and seconded by Beck.

2018 Byrne Justice Grant (JAG) Agreement between the City and County was presented by Burlington Police Chief Dennis Kramer. This agreement is approved every year. They will agree to use \$21,899 for the purchase of a Law Enforcement Simulation Range for county-wide Law Enforcement. The Simulator is interactive training and will be located in the basement of the Burlington Police Department. Broeker motioned to approve and seconded by Beck.

Interchange of Employee Agreement with Danville Community School District for School Year 2017/2018 was presented. Broeker motioned to approve and seconded by Beck.

Business Associate Agreement between Des Moines County and Iowa Counties Technology Services (ICTS) was presented. This agreement is in response to the 28E agreement between ICTS and SEIL. Broeker commented the agreement is in response to HIPAA requirements. Broeker motioned to approve and seconded by Beck.

The Assessor's list of 2018 Business Property Tax Credit Applications and removals was presented. Broeker motioned to approve the list and seconded by Beck.

Class C Liquor License for the Smith/Moret Wedding on 9/8/2018 was presented. Broeker motioned to

approve and seconded by Beck.

Appointments to the Compensation Board was presented. Dan Cahill requested to serve another four-year term as the Supervisors Representative and Richard Mellinger requested to serve another four-year term as the Treasurer's Representative. Beck motioned to approve both appointments and seconded by Broeker.

Resolution #2018-051 and Final Plat for Benedict Acres Subdivision was presented by Assistant Land Use Administrator Jarred Lassiter. This is a two-lot subdivision in part of the South ½ of Section 17 in Tama Twp. It is located north of Golf Course Road. The Owner/Subdivider is the Estate of James Benedict c/o Patricia Neal, 9516 Golf Course Road. The two-lots contain 27 acres and existing entrances will be used for each lot. The north boundary of the property was an issue due to the creek changing over the years. The City of Burlington approved the plat on August 13th and the fence waiver was approved. Beck motioned to approve and seconded by Broeker.

IOWA DEPARTMENT OF TRANSPORTATION AGREEMENT / RESOLUTION Sign Replacement Program for Cities & Counties (SRPFCC)

Applying as: County

RESOLUTION NO. 2018-052

WHEREAS the County of Des Moines, recognizes the importance of maintaining the regulatory, warning, and school area signs on the road system in conformance with the Manual on Uniform Traffic Control Devices, Federal Highway Administration, U.S. Department of Transportation, and

WHEREAS a review of signs has been conducted by the County of Des Moines or its agent to identify deficiencies in those signs eligible for replacement under the rules of the program, and

WHEREAS the Iowa Department of Transportation will reimburse up to \$10,000 per county and \$5,000 per city for conforming regulatory, warning, and school area signing materials for the replacement of existing signs to the County of Des Moines, and

WHEREAS it is understood that applications will be considered in order of receipt and will be limited to replacing eligible regulatory, warning, and school area signs. See, "Signs eligible for SRPFCC".

NOW THEREFORE BE IT AGREED BY THE IOWA COUNTY OR CITY COUNCIL OF DES MOINES, THAT:

The County is hereby directed to submit the grant application and request for signing materials to replace signs that have been identified as deficient in their review. This application is to be submitted to the Iowa Department of Transportation's Program Coordinator for the Sign Replacement Program for Cities & Counties, and

BE IT FURTHER RESOLVED THAT:

- A) All signing materials must be ordered within 90 days of application approval.
- B) All signing materials will be installed by the County of Des Moines, within 180 days after the sign materials are furnished, and,
- C) All signs will be installed in compliance with the Manual of Uniform Traffic Control Devices, Federal Highway Administration, U.S. Department of Transportation, as adopted per Iowa Administrative Rules 761, Chapter 130, and,
- D) The County of Des Moines, will certify in writing to the Department of Transportation's Program Coordinator within 30 days after the sign materials and/or signs have been installed.
- E) The County of Des Moines, recognizes that submission of this agreement along with an application, requesting signs and sign posts, represents approval by the city/county to participate in the Sign Replacement Program for Cities & Counties.
- F) Cities and counties not complying with the SRPFCC rules will be prohibited from applying for the program for two years.
- G) Application must be approved by Iowa DOT prior to ordering signs. Reimbursement, up to the program maximum, will be sent to the grantee AFTER the signs/posts have been installed, the DOT receives a copy of the sign-order invoice and the cancelled sign-order payment check.
