## November 20th, 2018

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, November 20<sup>th</sup>, 2018 with Chairman Jim Cary, Vice-Chair Tom Broeker and Member Bob Beck present.

Changes to Tentative Agenda. Work Session with the County Engineer - Road Tour was removed.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: County Auditor Terri Johnson reported the Post-Election Audit was held on Thursday, November 15<sup>th</sup>. The Secretary of State's Office choose Pct MY to be audited. The hand count results from the audit board matched perfectly with the election day machine results. Johnson presented the Board with a copy of the Post-Election Audit Report / Auditor Certification. County Recorder Lisa Schreiner stated her office is busy and to date 70 ATV permits have been issued. Her office is still busy digitizing records. County Attorneyelect Lisa Schaefer was present. She is currently working on transitioning and closing cases from her private practice. Schaefer has setup meetings with local law enforcement to discuss issues and changes between them and the County Attorney's Office. CDS Director Ken Hyndman attended SEIL meetings last week. They discussed Mobile Crisis Response, Recovery Center reports and CIT Training. Hyndman stated there is lots of progress. County Attorney Amy Beavers reported her office is busy. There was a trail team meeting today and they have 43 cases on the jury trial list for November 27<sup>th</sup>. They also wrapped up the 2<sup>nd</sup> conviction from the Kedarie Johnson murder trial. Secondary Roads Administrative Assistant Julie Winter stated winter came early with another snow event over the weekend. Others present were: Safety Director Angie Vaughan, Lieutenant Brett Grimshaw, IT Director Colin Gerst, Maintenance Supervisor Rodney Bliesener and Assistant Land Use Administrator Jarred Lassiter.

Correspondence. Beck read a letter received from the Burlington Area Veterans Council requesting a \$150 annual contribution for the upkeep of the US Service Flags at Memorial Auditorium.

Accounts Payable Claim in the amount of \$1,020,913.00 was presented. Broeker motioned to approve and seconded by Beck.

Payroll Reimbursement Claims in the amount of \$1,288.73 and Non-Cash Taxable in the amount of \$376.00 was presented. Beck motioned to approve and seconded by Broeker.

Personnel Actions: County Auditor – Aurey Kramer, Part-Time Clerk. Reclassification from Temporary Part-Time to Part-Time. Rate at \$12.00 hr., effective 11/19. Broeker motioned to approve and seconded by Beck. County Assessor - Kurt Schulte, Appraiser. New hire, new rate \$45,000 yr., effective 11/13. Broeker motioned to approve and seconded by Beck. County Attorney – Dawn Callison, Receptionist/Records Assistant. 18-month Step Increase. New rate \$31,658.50 yr., effective 11/22. Beck motioned to approve and seconded by Broeker.

Broeker motioned to approve minutes for the Board meeting held on November 13<sup>th</sup>, 2018 and Election Canvass on November 14<sup>th</sup>, 2018. Seconded by Beck.

Committee reports. Broeker attended SEIL meetings. He reported the CIT Training went well and graduated 15 officers from the first internal training. He met with the EmpowerU students and discussed the workings of county government. He attended a Greater Burlington Partnership meeting and they will change to bimonthly meetings. Beck attended a Community College-Fair Board Association meeting.
