February 19th, 2019

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, February 19th, 2019, with Chairman Tom Broeker, Vice-Chair Bob Beck and Member Jim Cary present.

Agenda items B and C and the work session with the Budget Director were removed.

Unless otherwise noted, all motions passed unanimously.

The Pledge of Allegiance was conducted.

Meet with Department Heads: County Auditor Terri Johnson reported the Burlington School District Special Election paperwork was received and the election will be held April 2nd. Sheriff Mike Johnstone stated his office will be swearing in Deputy Brad Siegfried as a Sergeant today. Johnstone stated he will be a great addition to the command staff. CDS Director Ken Hyndman stated DHS sent out an informational letter on a new managed care provider "Iowa Total Care" starting July 1st. IT Director Colin Gerst reported power outages downtown over the weekend, but the courthouse generators kept the servers operating. County Attorney Lisa Schaefer reported her office is busy. She has received a couple of resumes for the attorney position but none for the investigator position. She reminded everyone the Law Enforcement reception at her office will be held this Thursday. There is a jury trial this week. She has obtained two law school interns for this summer to work on various projects. County Engineer Brian Carter reported crews were out over the weekend. He thanked them. More snow is predicted tonight with possible ice and rain by the weekend. Supervisor Cary asked how the salt supply was holding up. Carter stated the County's salt stock was OK. Conservation Director Chris Lee stated there are lots of opportunities for ice fishing. Cloudy ice can turn bad quickly and to be careful when ice fishing. Maintenance Supervisor Rodney Bliesener reported his crews have been busy. The Courthouse was open during the President's Day holiday because the Courts were open. He reported the power outage started Sunday evening into Monday and it activated the generators for power. Others present were: Safety Director Angie Vaughan, Public Health Administrator Christa Poggemiller, Assistant Land Use Administrator Jarred Lassiter, and County Recorder Lisa Schreiner.

Correspondence. Supervisor Broeker read a letter received from American Ordnance regarding a Class 1 Permit Modification for RCRA Part "B" Permit (Installation Hazardous Waste Management Permit EPA RCRA ID# IA7213820445).

Accounts Payable Claims in the amount of \$1,144,861.94 was presented. Cary motioned to approve and seconded by Beck.
