The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, May 14th, 2019, with Chairman Tom Broeker and Member Jim Cary present. Vice-Chair Bob Beck was absent.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meet with Department Heads: County Auditor Terri Johnson stated her office is busy. Conservation Director Chris Lee reported last weekend was busy at Big Hollow with the Youth Jamboree event, approximately 400 attended. The Contractor moved into Big Hollow to start work on the pond retention project next to the campground. He is hoping the project will only take two weeks. This coming weekend is a buy two nights and get one night free at the Big Hollow, 4th Pumping Station or Welter campgrounds. Lee reported the Skunk River Sycamore Loop is open again. County Attorney Lisa Schaefer reported her office is busy with four jury trials this week. The new assistant attorney will start next month. CDS Director Ken Hyndman reported it is SEIL contracting time again and they are half done signing new provider contracts. Jail Administrator Doug Ervine reported the jail population is 90. Three can be transported to prison but are short on transport officers. Two inmates are awaiting pickup for Joliet. There will be an ad in the paper and on the county website for part-time transport officers. Sheriff Mike Johnstone stated his office is looking for a part-time Courthouse Security employee. Prefers someone with law enforcement background but not required. Public Health Administrator Christa Poggemiller stated they have a position open for a full-time Public Nurse and stated her office is busy. County Recorder Lisa Hazell stated her office is busy and 197 UTV permits have been sold. Maintenance Supervisor Rodney Bliesener reported on the installation of the Jail Control Panel. Johnson Controls will be in this week and hope to finish up this Thursday if everything goes as planned, then maintenance will install counters for the new layout of equipment. Others present: Asst. Land Use Administrator Jarred Lassiter. Secondary Roads Administrative Assistant Julie Winter, IT Director Colin Gerst, and County Treasurer Janelle Nalley-Londquist.

A Cigarette Renewal Permit for River Mart at 14562 Washington Rd., West Burlington was presented. Cary motioned to approve and seconded by Broeker.

Des Moines County Tax Sale Certificate #16-0417 to Kevin Liles, 501 Wightman St., Burlington was presented. Mr. Liles offered to pay 100% of the \$248 delinquent taxes owed on the parcel as well as the \$10.00 assignment fee. Cary motioned to approve and seconded by Broeker.

Resolution and Final Plat for Ribstone 66 Subdivision was presented. Assistant Land Use Administrator Jarred Lassiter discussed the subdivision. It is one-lot containing 1.0 acres in Section 8 of Pleasant Grove Twp. The owner/subdivider is Jeff & Lisa Fischer, 19504 220th Ave., New London. Access will be provided by a 35' wide driveway easement to 220th Ave. This lot is part of a cattle farm and will be used for an operation to compliment the farm. Lassiter recommended approval. Cary motioned to approve and seconded by Broeker.
