The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, April 21<sup>st</sup>, 2020, with Chairman Tom Broeker, Vice-Chair Bob Beck and Jim Cary present. Due to the Coronavirus Pandemic declaration, this meeting was held electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meet with Department Heads: County Auditor Terri Johnson gave a Primary Election update. A media news release has been sent to all papers and radio stations encouraging voters to vote by absentee due to COVID-19. The Iowa Secretary of State is sending absentee request forms to all active registered voters. All Auditors and the State want voters to protect themselves and the Precinct Election Officials and to please stay at home and vote at home. Ballots will start being mailed on April 23<sup>rd</sup> and in-person absentee voting at the Courthouse will begin May 4<sup>th</sup>. In-Person voting will most likely be curbside voting by appointment only. IT Director Colin Gerst reported his office is busy. Via Webex: County Engineer Brian Carter reported paving on North Gear Ave is moving along. There is new paving on the hill and working towards the south. Mediapolis Road bridges have been removed and the contractor is removing the old abutments. Iowa City Road, the north  $\frac{1}{2}$  of intersection along Mediapolis Road is being poured. The contractor's rock supplier from Columbus Junction area, had to shut down due to COVID-19. They have since reopened but then their equipment broke down slowing progress. Three bids are out and will be reviewed on April 30th and May 7th. Conservation Director Chris Lee reported they are starting on last year's FEMA projects on Starr's Cave trails. The trail is closed while they haul sand and flood debris from the trail. Welter Campground and trail segments are being repaired. Lee reported there are a lot of people using the parks, trails, and fishing. Jail Administrator Doug Ervine reported everything was going well and the current jail population is 54. This is mainly due to the court system and County Attorney working well on establishing policy. He thanked Maintenance Department employee Jack Brissey for getting the video visitation system working. There are five prisoners housed out of county due to spacing issues. No problems getting anyone to prison. Emergency Management Coordinator Gina Hardin stated the river level is going down. We are below major flood stage and currently in moderate flood stage, and should be out of any flood stage by 1<sup>st</sup> of May. Local Health Administrator Christa Poggemiller reported her office is busy. There are 14 confirmed cases of COVID-19 in Des Moines County. The State reports 3 are recovered. CDS Director Ken Hyndman is still holding contract meetings via ZOOM for SEIL services. Clerk of Court Jackie Myers stated everything is going well and is alternating staff. There are no inperson hearings unless there are special circumstances or emergency type matters. They can accept filings by email and keep pushing court dates back. County Treasurer Janelle Nalley-Londquist continues to keep busy and is accepting payments for real estate and car license and titles. She wanted to remind everyone property tax payments can continue to be accepted thru April 30th without interest. County Attorney Lisa Schaefer reported her office is staving busy. She mentioned the State Auditor's report was released regarding purchases made by former Chief Deputy Jeff White. Her office will not be involved, and the Attorney General's Office has assigned an attorney to the case. Assistant Land Use Administrator Jarred Lassiter reported they are still receiving a few inquiries regarding subdivisions, etc. Safety Director Angie Vaughan reported she is working with Fire Departments regarding N95 mask fitting.

COVID-19 update. Emergency Management Coordinator Gina Hardin reported they are still putting in orders to the state for Personal Protection Equipment (PPE). They are looking at different grants to help the community. Local Health Administrator Christa Poggemiller reported they continue to work at the Emergency Operations Center (EOC). Some masks have been received. Hand sanitizer is in route. Beck asked about testing for COVID-19. Poggemiller stated testing is done using nasal swabs. Blood testing is for checking for antibodies. Broeker thanked Hardin, Poggemiller and Tammy at GRMC for everyone working together so well during this time.

Correspondence. Broeker stated he received a report from Southeast Iowa Regional Riverboat Commission. Revenues are down and will go down further since the casino is closed due to COVID-19. The Dewey Byar Trust report was received. Income from the trust takes about 2-1/2 cents off the tax levy which offsets property taxes. Cary received a call from someone asking about rural cleanups. The rural cleanup has been put on hold due to COVID-19.

Accounts payable in the amount of \$1,058,208.22 was presented. Beck motioned to approve and seconded by Cary.

Payroll Claims Reimbursements in the amount of \$183.90 was presented. Beck motioned to approve and seconded by Cary.

Resolution and Final Plat for Second Addition to Thye Subdivision was presented. Via Webex – Assistant Land Use Administrator Jarred Lassiter discussed the subdivision. This is a one-lot subdivision containing 1.31 acres in Benton Twp on 155<sup>th</sup> Street. The owner/subdivider is Dusty & Vickie Thye, 10284 155<sup>th</sup> St., Burlington. Lassiter recommended approval. Cary motioned to approve and seconded by Beck.
