The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, April 28th, 2020, with Chairman Tom Broeker via Webex, Vice-Chair Bob Beck and Jim Cary present. Due to the Coronavirus Pandemic declaration, this meeting was held electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meet with Department Heads: County Auditor Terri Johnson reported on the 2020 Primary Election. The Iowa Secretary of State's Office has mailed absentee request forms to every active registered voter in Iowa. The form should be delivered to mailboxes starting Wednesday. Johnson discussed a news release she will distribute to the media stating in-person absentee voting begins Monday, May 4th at the courthouse. However, due to COVID-19 restrictions will apply. In-person voting will be by appointment only and will be conducted curbside. Parking spaces in the south parking lot will be reserved for curbside voting. All County Auditors are encouraging their residents wanting to vote to please vote by mail. Johnson reminded everyone all county precincts will be temporarily combined into two for the Primary election. IT Director Colin Gerst reported his department has been busy with electronic meetings. Via Webex: Maintenance Supervisor Rodney Bliesener reported a lot has been going on and preparing the courthouse for eventual opening. County Engineer Brian Carter reported North Gear Ave and Iowa City Road paving is continuing. Dust control will be applied on some routes soon and the larger portion of county dust control will start next week. The Mediapolis Road bridge project is moving along. Hartman Road received a beating during construction at the airport. Carter reported more rock has been added to this road and they will continue to monitor the situation. Conservation Director Chris Lee sated the parks are busy. The FEMA project to cleanup up the Flint River Trail through Starr's Cave should be wrapping up today or tomorrow. Lee stated the contractor will begin work on the Welters Park / Maple Leaf Campground. CDS Director Ken Hyndman reported SEIL Region has four more contract meetings scheduled this week. Assistant Land Use Administrator Jarred Lassiter stated last week was an active week. Clerk of Court Jackie Myers stated everything is going well and still alternating staff. There are no in person hearings unless there is an emergency. County Treasurer Janelle Nalley-Londquist reported March tax payments are not assessed interest thru May 27th per Governor's Proclamation. The proclamation includes extension of delinquency tax sales and title transfer deadlines. County Attorney Lisa Schaefer reported her office is staying busy and using the time to clean out old files stored in the basement at the courthouse. Most of the files are no longer needed and will reorganize the kept files into one location. They will eventually go paperless with a new cloud-based file system. Safety Director Angie Vaughan reported she is keeping busy and has seen a big decrease in incidents and accidents, Local Health Administrator Christa Poggemiller reported her department is busy. Des Moines County has seventeen COVID-19 cases and discussed Governor Reynold's Proclamation on April 27th. Emergency Management Coordinator Gina Hardin has submitted paperwork for non-congregate housing for COVID-19. Hardin reported Des Moines County is now below flood stage. SEIRPC is working on updating the Hazard Mitigation Plan. The plan has been sent to several departments for review. Jarred Lassiter, SEIRPC stated they have been getting some feedback from departments for the updated plan.

Public Hearing for FY20 Budget Amendment. Beck motioned to open the public hearing and seconded by Cary. Budget Director Cheryl McVey spoke about the budget amendment request. No written or public comments were received. Beck motioned to close the public hearing and seconded by Cary. Cary motioned to approve the FY20 Budget Amendment and seconded by Beck.
