The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, July 21st, 2020, with Vice-Chair Jim Cary and Member Bob Beck present. Chairman Tom Broeker was absent. This meeting was held with limited capacity due to COVID-19 and electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meet with Department Heads: County Auditor Terri Johnson reported the Iowa Secretary of State presented an Emergency Election Directive to the Legislative Council last Friday. The Council approved the directive; therefore, the Iowa Secretary of State will mail absentee request forms to all registered voters in Iowa for the November General Election. The forms will not be mailed until late August. Johnson stated her office will continue to mail absentee forms to those requesting a form. The Mediapolis School Special Election ballots have been received but will not be available for voting until August 10th. IT Director Colin Gerst reported his office is busy. Sheriff Mike Johnstone reported everything is going well and they are busy. They are in the hiring process to fill two positions and the river patrol has been busy. Jail Administrator Doug Ervine stated the population is 67. Five or six inmates are waiting to go to other facilities but have to pass a COVID test prior to transportation. Recently one inmate tested positive without any symptoms. They will be providing testing for the staff. Safety Director Angie Vaughan reported a city road crew member was hit by a car intentionally. She asked if fines could be increased similar to those of highway construction fines. CDS Director Ken Hyndman reported SEIL has a mobile crisis unit in eight of the region's counties. County Engineer Brian Carter gave an update on road projects. Gear Avenue is now open. Upper Flint Road may have a concrete pour next week. Mediapolis Road project is setting the bridge decks. Via Webex: Maintenance Supervisor Rodney Bliesener reported his department is busy. He stated on Wednesday the sidewalk in front of the courthouse will have a couple of sections replaced. The front doors will be open during this time only because the sidewalk will be closed. The sidewalk replacement should only take one day. Conservation Director Chris Lee reported teams are out cleaning up storm damage on the trails. FEMA contractors are waiting on rock to be crushed to complete their projects. Lee stated his large group meetings including Summer Celebration and Volunteer Dinner have been cancelled due to COVID. Assistant Land Use Administrator Jarred Lassiter reported they have been busy. Clerk of Court Jackie Myers reported her offices have been busy with inperson hearings now taking place. County Attorney Lisa Schaefer reported an Assistant County Attorney has resigned and she is actively looking for a replacement. They are working on the Karpel project and busy with inperson trials. She thanked the Board and Auditor for allowing use of the Board meeting room for depositions to meet the distancing requirement.

Accounts Payable Claims in the amount of \$1,046,938.68 was presented. Beck motioned to approve and seconded by Cary.

Cigarette/Tobacco License for River Mart was presented. Beck motioned to approve and seconded by Cary.

Class C Liquor License for Your Private Bar at Barn on the Ridge for 8/11 was presented. Beck motioned to approve and seconded by Cary.
