The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, October 5th, 2021 with Chairman Tom Broeker, Vice-Chair Jim Cary and Member Shane McCampbell present. This meeting was also held electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meet with Department Heads: County Payroll 1st Deputy Sara Doty stated she continues to stay busy. County Attorney Lisa Schaffer reported that her office is busy. County IT Director Colin Gerst reported his office as busy. Sheriff Kevin Glendening stated everything is going well. Maintenance Supervisor Rodney Bliesener stated they are busy preparing for the upcoming winter months. Land Use Administrator Zach James reports they have an agenda item for the Floodplain Ordinance. County Auditor Terri Johnson reported the City Primary Election is currently going on. The polls close at 8:00 p.m. tonight. The canvass will be Thursday, October 7th at 1:00 p.m. County Recorder Natalie Steffener reported the OHV and Snowmobiles tags expire December 31st. You can start renewing them now. If you wish to purchase a county permit you have to have proof of insurance to do so. County Treasurer Janelle Nalley-Londquist reported her office is staying busy. Safety Director Angela Vaughan reported she is staying busy. Jail Administrator Doug Ervine reported the Jail population is 75 with 5 out of county. Public Health Administrator Christa Poggemiller reported her office is busy. They are currently holding vaccine drive-thru clinics at SCC. They will be holding them every Monday, Wednesday, and Friday from 8:30 a.m. to 4:00 p.m. You can sign up on the county website or call 319-208-5668.

Correspondence – Chairman Broeker stated that he received a letter from the Department of Army. The U.S. Environmental Protection Agency has approved a class II Permit modification that the Iowa Army Ammunition Plant requested. This permit modification allows the addition of a new overburden groundwater monitoring well MW20-01 to the monitoring network at the facility downgradient from an existing well C-00-1 to delineate volatile organic compounds in the shallow aquifer for the Ash Disposal Cell within Trench 5. It also allows the removal of seep/surface water sampling from an existing monitoring well CEA-POOL-UPST.

Accounts Payable in the amount of \$801,428.42 was presented. Cary motioned to approve and seconded by McCampbell.

Payroll Claims Reimbursements of \$485.84 and Non-Cash Taxable of \$53.51 was presented. McCampbell motioned to approve and seconded by Cary.

The 2nd Public Hearing for Floodplain Development Ordinance #25 was motioned to go into session by Cary and seconded by McCampbell. Some discussion ensued. The Auditor stated no public comments were received. Cary made a motion to close the public hearing and McCampbell seconded. McCampbell made a motion to approve the Ordinance and waive the 3rd Hearing seconded by Cary.

County Rural Resident Clean-Up was motioned for approval by Cary and seconded by McCampbell. This will take place from October 11th – December 18th or until the county credits are depleted.

Personnel Actions: Recorder's Office – Renae Welborn, Clerk II, 6 month step increase beginning 10/12. McCampbell motioned to approve and seconded by Cary. Sheriff - Deputy Brandon McLeland, 6 month step increase effective 09/08. Cary motioned to approve and seconded by McCampbell. Jail – Tucker Hulse, Full Time Correctional Officer resigned from full time and will begin as part time on 10/9. McCampbell motioned to approve and seconded by Cary.

Cary motioned to approve the September 28th, 2021 meeting minutes and seconded by McCampbell.

Future Agenda Item: Work Session with Carl A. Nelson, County Engineer Brian Carter, Land Use Administrator Zach James and the Board of Supervisors regarding the new Public Health building.

No public input was received.
