Ordinance No. 61

AN ORDINANCE ESTABLISHING VOTING PRECINCTS FOR DES MOINES COUNTY, IOWA

Be it enacted by the Board of Supervisors of Des Moines County, Iowa:

Section 1. Purpose. The purpose of this ordinance is to establish voting precincts as a result of the population changes reflected by the 2020 Census for Des Moines County, as required by Chapter 49.4 and 49.7, Code of Iowa.

Section 2. Definitions. For use in this ordinance, the following terms or words shall be interpreted or defined as follows:

1. "Voting Precinct" or "Precinct" shall mean a county or municipal subdivision for casting and counting votes in elections.

2. "Township" shall mean a civil and political subdivision of the county.

Section 3. Boundaries of Voting Precincts. Des Moines County shall have the following voting precincts in addition to an absentee voting precinct as required by law, whose boundaries shall be as follows:

City of Burlington – Pct 1, 2, 3, 4, 5, 6, 7 and 8 as established by City of Burlington Ordinance No. 3493 approved and adopted December 20, 2021

Precinct BHJ – Benton Twp, Huron Twp and Jackson Twp

Precinct CC – Concordia Twp

Precinct DM - City of Danville and Danville Twp

Precinct FM - Flint River Twp and City of Middletown

Precinct MYF - City of Mediapolis, Yellow Spring Twp and Franklin Twp

Precinct PW – Pleasant Grove Twp and Washington Twp

Precinct Tama – Tama Twp

Precinct UN – Union Twp

Precinct WB – City of West Burlington

- Section 5. Repealer. All other ordinances or parts of ordinances in conflict with the provisions of this ordinance, including Des Moines County Ordinance No. 54 and Amended Ordinance No. 54 in its entirety, are hereby repealed.
- Section 6. Severability Clause. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any part thereof not adjudged invalid or unconstitutional.
- Section 7. When Effective. This ordinance shall be effective after its final passage, approval, and publication as provided by law.





CONTRACT FOR LEGAL SERVICES

IT IS AGREED between Des Moines County, Iowa ("County"), and Lynch Dallas, P.C. ("Attorneys"), as follows:

1. **LEGAL SERVICES.** Lynch Dallas, P.C. will serve as attorney for the County and will provide legal services on an as-needed basis.

2. **EXPENSES.** In addition to payment for fees, the County shall reimburse Attorneys for reasonable expenses incurred on behalf of the County, including but not limited to federal mileage rate for travel; cost of securing records or documents, photographs, hospital records, medical reports, medical examinations; filing fees; court costs; depositions; expert witness fees; and other reasonable expenses incurred by Attorneys for the County. In the case of very large expenses, the County may be required to pay said expenses directly or in advance. Any unpaid expense will be billed periodically by Attorneys and will be paid by County upon billing. Any unused expense money advanced to Attorneys by the County shall be refunded to the County.

3. FEES. The County shall pay Attorneys for fees at the following hourly rates:

Shareholders	\$175.00
Associates	\$160.00
Legal Assistants	\$90.00

The County shall be billed at one-half an attorney's usual hourly rate for travel time, plus reimbursement for mileage at the federal rate, as set forth above. Unless otherwise agreed, the County shall pay for only one attorney at meetings, or a combined fee and mileage equal to the rate of one attorney, regardless of whether one or more attorney is present.

4. **BILLING.** The County shall be billed monthly for fees and expenses incurred in the previous month. Attorneys shall bill in increments of .1 (one-tenth) of an hour, and each entry shall be separately accounted and described. It is the County's responsibility to ask questions if a bill requires clarification. Bills shall be paid within thirty (30) days of receipt.

5. **PLACE OF PAYMENT.** All sums due shall be paid at Attorneys' office, Lynch Dallas, P.C., P.O. Box 2457, 526 Second Avenue SE, Cedar Rapids, Iowa 52406-2457.

6. **COMMUNICATION.** Consistent with the County's desire to balance the efficient control of legal expenses with the need for the County's politically elected to leaders to be kept aware of important developments, Attorneys shall use reasonable best efforts to ensure the **Board Chairman** and the Board of Supervisors are appropriately informed of ongoing matters and questions are answered promptly. The County's points of contact with the authority to authorize legal work and advice shall be the Board Chairman and all

Department Heads unless or until additional authorization is provided by the Board Chairman.

7. **CONTINUING AGREEMENT AND RATE ADJUSTMENT.** This agreement shall continue in full force and effect without action of the parties. Considering the ongoing nature of this agreement, it may be necessary for Attorneys to periodically adjust hourly rates and/or expenses to account for changing market conditions. Attorneys shall submit hourly rate and/or expense adjustments to the County in writing on or before January 1 of the year during which the adjusted hourly rates and/or expenses to automatically take effect on July 1st of said year.

8. **TERMINATION.** This agreement may be terminated by either party at any time by providing ninety (90) days written notice to the other party.

9. **RECORDS.** At the County's request upon termination, any documents furnished by the County will be returned promptly upon receipt of payment for outstanding fees and charges. Attorneys' files, including attorney work product, pertaining to the above referenced representation will be retained by Attorneys. For various reasons, including the minimization of unnecessary storage expenses, Attorneys reserve the right to dispose of any documents or other material retained by Attorneys following termination of this engagement in accordance with applicable industry standards.

28E AGREEMENT BETWEEN THE CITIES OF BURLINGTON AND MEDIAPOLIS, IOWA AND DES MOINES COUNTY, IOWA

This Agreement is made and entered into by and between the City of Burlington, Iowa, by and through its Library Board of Trustees, hereinafter "Burlington", the City of Mediapolis, Iowa, by and through its Library Board of Trustees, hereinafter "Mediapolis", and Des Moines County, Iowa, by and through its Board of Supervisors, hereinafter "County", effective July 1, 2022.

NO ENTITY CREATED

No independent or separate entity is created by this Agreement.

DURATION

This Agreement shall continue for a period of ten (10) years beginning FY23 (July 2022-June 2023) and automatically renew, unless otherwise modified, amended, or terminated as hereinafter provided. Entities will meet prior to the renewal, at least every 10 years. [Is this the best place for this statement.]

PURPOSE

Both Burlington and Mediapolis hava a publicly funded library operating pursuant to Chapter 336 of the Code of Iowa. Des Moines County has requested that Burlington and Mediapolis provide library services to the residents of the unincorporated areas of Des Moines County.

The purpose of this Agreement is to allow all parties to work in cooperation to provide essential library services within their respective jurisdictions pursuant to Chapter 28E of the Code of Iowa.

AGREEMENT

In consideration of the mutual covenants and promises contained herein and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, Burlington Mediapolis and County agree as follows:

1 County agrees to pay the Administrator of the Agreement \$145,220.70 for FY23 (July 2022-June 2023).

2 The annual amount will increase by 2% annually each succeeding year.

3 The annual amount will be billed by the Administrator to County no later than November 1 of each year, with the annual amount being payable in two equal installments no later than December 15 and June 15 of each year.

4 Burlington and Mediapolis agree that the annual payments will be divided with 25% to Mediapolis and 75% to Burlington.

5 County agrees that the use by residents of the unincorporated areas of Des Moines County of Burlington and Mediapolis' facilities and services shall be subject to the rules and regulations of the Library Board of Trustees of each entity.

ADMINISTRATOR

Burlington's Library Director shall act as Administrator of this Agreement. The Administrator shall be responsible for filing this Agreement with the Secretary of State of the State of Iowa along with any additional filings required pursuant to Section 28E.8 of the Code of Iowa.

APPLICABLE LAW

This Agreement is entered into under the provisions of Chapter 28E of Iowa, and is subject to the powers and limitations contained therein.

DIVISION OF ASSETS

There shall be no division of assets upon termination of this Agreement since all property belongs to Burlington or Mediapolis.

AMENDMENTS

Amendments or modifications to this Agreements may be made from time to time. Any such amendments, modifications, or notice of termination must be in writing, approved by all parties to this Agreement, and filed with the Secretary of State in conformance with Section 28E.8(1)(b) of the Code of Iowa.

WITHDRAWAL FROM AGREEMENT AND TERMINATION

All parties agree that no entity shall be permitted to withdraw from this Agreement for the first five (5) years. Thereafter a party may be allowed to withdraw but only after serving all other entities with a written notice of intent to withdraw, said notice to be served a minimum of six (6) months in advance of the prospective withdrawal date. Service of the notice shall be made by personal delivery to the other parties or by mailing a copy of said notice by certified mail, return receipt requested, to the other parties. Upon withdrawal, County agrees to pay its annual payments set forth above for the following three succeeding years. Upon withdrawal Burlington and Mediapolis agree that the withdrawing party remains obligated to continue to provide library services for the three succeeding years. At the end of the said three years, this Agreement will terminate with respect to the withdrawing entity.

ADDITIONAL ENTITIES

Additional entities may become a party to the Agreement but only upon unanimous consent of all parties to this agreement. [Do we need this section or is it covered by the Amendments section?]


