- I. <u>Opening Protocol</u>
 - A. *Call to Order* by Chair Broeker at 5:00 PM.

IV. <u>New Business- DESCOM</u>

A. DESCOM Employee Appeal.

The DESCOM Control Board met to hear an appeal from DESCOM operator, Caili Rodeffer, regarding sick leave accumulation. Participants included the appellant, DESCOM director – Shanna Krogmeier,

DESCOM union steward – Kevin Newberry, and CWA President – Adam Plein.

The DESCOM Control Board heard testimony from and asked questions of the appellant and other participants.

Ms. Rodeffer left full-time employment with DESCOM in the summer of 2021 and moved to a part-time status. After an employment offer from the DESCOM director, she returned to full-time status in December of 2021. Shortly thereafter, the sick leave she had accumulated prior to moving to part-time status was removed in accordance with Des Moines County and DESCOM policy that sick leave accumulation is lost when an employee leaves full-time employment except for a bonafide retirement.

Findings of the DESCOM Control Board:

There was an unwritten offer of employment to appellant from DESCOM director. That offer included reinstatement of her seniority, benefits, and accrual rates. The offer was not in writing, and the specific inclusion or exclusion of accrued sick leave benefits was apparently not discussed. The board found that there was sufficient evidence for appellant to genuinely believe that reinstatement of accrued sick leave was a component of the offer of employment.

Actions of the DESCOM Control Board:

- Appellant was granted reinstatement of her accrued sick leave.
- To prevent such miscommunications in future, the DESCOM Control Board instructed the DESCOM director that any and all offers of employment outside of union contract shall be in writing and submitted to the Control Board prior to the offer being made.
