This meeting was also held electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Organization of the 2023 Board of Supervisors was conducted. Cary made a motion to nominate McCampbell for Chair, Broeker for Vice-Chair and was seconded by Broeker. The meeting was then conducted by Chairman Shane McCampbell.

Judge Joshua Schier administered the oath of office to appoint Sara Doty as County Auditor. Doty will serve the balance of Terri Johnson's term until after the canvass of votes for either a petitioned Special Election to fill the vacancy or when the seat appears on the November 5, 2024 General Election.

County Engineer Brian Carter stated Highway 99 Bridge construction should start back up today. The bridge work on 165th Avenue should start soon as well. Maintenance Director Rodney Bliesener reported he has been short staffed due to illness, so he is working hard to get things caught up. Budget Director Cheryl McVey reported budget hearings will begin today. SEIL CDS Director Ken Hyndman gave a SEIL update. Conservation Director Chris Lee reported the ice on the ponds is not as frozen as it has been with the warmer temperatures. Please be cautious anytime during the winter when going on the ice. Conservation held a winter camp at Starr's Cave last week and they had a great turn out. County Treasurer Janelle Nalley-Londquist reported the office is busy. Auditor Sara Doty would like to thank everyone for the support through the transition of Terri retiring. Doty is currently working on getting a new Payroll Deputy hired for the office.
